Resolutions

Recognition of traditional custodians of the land

25.01 The Synod acknowledged the traditional custodians of the land on which the 38th Synod met, the Yuggera, Turrbal, Kabi Kabi and Gubbi Gubbi peoples, and gave thanks for their elders past and present, and their stewardship of the lands, waters and stories.

The Synod acknowledged the traditional owners including:

Aunty Helena Gulash Aunty Kim Harrison Uncle Tais Muckan Aunty Beverly Muckan Aunty Cecilia Combo Uncle Norman Bond

Uncle Rodney Minniecon (Congress Elder and Kabi Kabi man), his family, and Sharyn Malone (Kabi Kabi woman with ties to Cherbourg) welcomed the Synod to Country.

Procedural Proposals

25.02 It was **Resolved by Consensus** that the Synod:

(a) Notes the appointment by the Synod Standing Committee of members of the Business Committee and the authorisation by Synod Standing Committee to the Moderator, Moderator Elect and General Secretary to make further appointments to the Business Committee:

Rev Dr Adam McIntosh (General Secretary)

Rev Brian Hoole

Ms Kym Korbe (Executive Officer UAICC)

Ms Vanessa Van Der Rhede (Events Specialist)

Mr Simon Moore (Corporate Governance Specialist)

(b) Notes the further appointments made pursuant to (a):

- (c) Appoints Rev Brian Hoole as Convenor of the Business Committee.
- (d) Authorises the Committee to co-opt other persons as necessary for specific business.

25.03 It was **Resolved by Consensus** that the Synod:

(a) Appoints Rev David Busch as Convenor of the Facilitation Group and authorises the Convenor to co-opt members for that Group; and



- (b) Appoints Ms Kym Korbe and Rev Kath Behan as Yarning Circle Co-ordinators and authorises the Coordinators to co-opt members for that purpose.
- 25.04 It was <u>Resolved by Consensus</u> that the Synod appoints Mr Simon Moore as Minute Secretary.
- 25.05 It was **Resolved by Consensus** that the Synod appoints Rev Jenny Potter as Convenor of the Ballot Committee and authorises the Convener to co-opt members as necessary.
- 25.06 It was <u>Resolved by Consensus</u> that the Synod appoints Rev Heather Allison, Rev Dan Skippen, Rev James Stevenson and Ms Moana Teulilo-schaaf as Pastoral Coordinators.
- 25.07 It was <u>Resolved by Consensus</u> that the Synod adopts the Roll of the Synod subject to the Roll only containing the names of those members who register by 10.30am (QLD Time) on Saturday, 17 May 2025.
- 25.08 It was **Resolved by Consensus** that the Synod:
 - (a) Determines that unless otherwise agreed, the hours of session for the Synod shall be:

Thursday, 15 May 2025	1.00 pm – 4.00 pm
Friday, 16 May 2025	9.00 am – 9.00 pm
Saturday, 17 May 2025	8.30am - 8.30 pm
Sunday, 18 May 2025	8.30 am – 8.30 pm
Monday, 19 May 2025	8.30 am – 4.30 pm

- (b) Adopts the timetable and order of business as determined daily by the Business Committee unless the Synod specifically determines otherwise.
- 25.09 It was <u>Resolved by Consensus</u> that the Synod determines that the Bar of the House be defined as the numbered tables in the auditorium, unless numbered tables are not present, in which case the Bar of the House be defined as the auditorium.
- 25.10 It was **Resolved by Consensus** that the Synod:
 - (a) Adopts the use of the procedures of *A Manual for Meetings in the Uniting Church* (2015).
 - (b) Determines that "leave of the council" be a simple majority. Note that this applies to the procedural proposal "Determining the need for a decision now" (5.6.16 and 6.10). Refer below for rationale.
 - (c) Determines that members should introduce themselves the first time they speak from the floor of Synod in the order of a-c below and that subsequent introductions only require their name and Presbytery or other appointing body to the Synod. The initial introduction should include:
 - a. Name
 - b. Presbytery or other appointing body to the Synod
 - Naming the traditional owners of the lands on which they live, if known
 - (d) Determines that members asking questions from the floor of Synod, speak within the following bounds:
 - a. Two (2) minutes or less during information
 - b. Three (3) minutes or less during deliberations
 - c. Two (2) minute or less during decisions.



25.11 It was **Resolved by Consensus** that the Synod:

- (a) Determines that the ballots will be held as determined by the Business Committee.
- (b) Determines that members must be present in person to cast their ballot. If the meeting is an online meeting, members must be present online to cast their ballot. Voting by proxy is not permitted.
- (c) Determines that ballots for Synod governing bodies be written ballots conducted by secret ballot, including by electronic means, and any proceedings in formal majority.
- (d) Determines that any ballot taken as part of formal procedures shall be conducted by secret ballot, including by electronic means.
- (e) Determines that a ballot for a proposal for the appointment of the Moderator elect will be conducted by secret preferential ballot. Where there is only one nomination for the Moderator elect role a secret ballot shall be conducted with the proposal requiring not less than 65% support of ballots received for the proposal to pass.

25.12 It was **Resolved by Consensus** that the Synod:

- (a) Endorses the nomination date as 11th April 2025.
- (b) Determines that the following positions will be available for nomination for election at the Synod:
 - i. One (1) position for the Chair of the Uniting Church in Australia Property Trust (Q.). The person elected to that role will also be the Chair of the Finance Investment and Property (FIP) Board.
 - ii. One (1) position for the Secretary of the Uniting Church in Australia Property Trust (Q.).
 - iii. Three (3) positions for members of the Uniting Church in Australia Property Trust (Q.).
 - iv. Seven (7) positions for members of the Synod Standing Committee.
 - v. One (1) position for Chair of the Board of Christian Formation (BCF)
 - vi. Three (3) positions for members of the Board of Christian Formation (BCF)
 - vii. One (1) position as Moderator elect
- (c) Endorses that nominations received on or prior to the nomination date will be presented to Synod.
- (d) Determines that of the 7 positions available for election to the Synod Standing Committee, 4 positions shall be elected for two synodal terms (3 years), and 3 positions shall be elected for 1 synodal term (18 months).
 - i. The positions to be elected for 2 synodal terms shall be filled as a priority, except where:
 - a) A person is only eligible to serve for one synodal term due to existing service on the Synod Standing Committee.
 - b) A person has agreed or is only eligible to be elected for one synodal term.
 - c) The positions are only open to persons who meet eligibility requirements as follows:
 - At least 50% of the persons declared elected to fill the required number of elected member positions at the Synod meeting must be female. (Queensland Synod By-law Q2.2.13(3))



- Lay members shall be not fewer in number than the ministerial members (Regulation 3.7.4.1(b) and Queensland By-laws (Q2.2.3(d))
- (e) In addition to 1.10.2(d)(i), the following will be applied in determining the priority of the ballot for the Synod Standing Committee:
 - Members of Synod nominated for election to the Synod Standing Committee with the highest number of votes will be appointed in progressive order subject to their gender and lay/ordained status:
 - Two women who receive the first and second highest number of votes for women will be appointed to the 40th Synod. Both may be ordained.
 - b) Two women who receive the third and fourth highest number of votes for women will be appointed to the 39th Synod. Both may be ordained if the three ordained positions have not already been filled.
 - c) Two men who receive the first and second highest number of votes for men will be appointed to the 40th Synod. Both may be ordained if the three ordained positions have not already been filled.
 - d) One man who receives the third highest votes for men will be appointed to the 39th Synod. This position may be ordained if the three ordained positions have not already been filled.
 - ii. It is understood (a) through (d) above may result in a role not being filled or a person with higher votes not being elected to the Synod Standing Committee.
- 25.13 It was **Resolved by Consensus** that the Synod determines the voting procedures for Synod Governing bodies, as follows:
 - (a) Where the number of candidates is equal to or less than the number of available positions, each candidate must receive an absolute majority (more than 50%) of the votes cast in favour to be elected to the position.
 - (b) Where the number of candidates exceeds the number of available positions:
 - i. each member of the Synod shall have up to the same number of votes as the number of positions available.
 - ii. the voter shall be required to indicate "for", "against" or "abstain" for the election of each candidate and the candidates receiving the highest number of "for "votes are elected in progressive order until all vacant positions are filled.
 - (c) Where candidates receive an equal number of "for" votes they are allocated to the remaining positions available.
 - (d) Where there are more candidates with equal "for" votes than available positions, the candidate to be elected to the position will be determined by lot. The method of determination by lot is at the discretion of the Balloting Convenor.
 - (e) If there are insufficient candidates for available positions, a casual vacancy is created. The Moderator shall, according to Regulation 3.6.3.2 (e), identify and appoint eligible candidates to any remaining positions, no later than two months after the close of the Synod.
 - (f) If only one person is to be elected and more than one person is nominated:



- i. the election shall be by preferential ballot;
- ii. if the ballot is undertaken by electronic means then the system chosen must allow for a preferential ballot and that items (c) through (k) will be managed within the system and without manual intervention.
- iii. each member of the Synod shall have the number of votes equal to the number of persons to be elected;
- iv. each voter shall record a vote on the ballot paper by placing the number "1" opposite the name of the nominee for who it is desired to give the first preference vote and shall give contingent votes for all the remaining nominees by placing the numbers "2", "3", "4" and so on as the case may require opposite the names of such nominees so as to indicate by numerical sequence in the order of the voter's preferences for them;
- v. upon the close of the ballot the scrutineers shall proceed to count the total number of first preference votes recorded for each nominee;
- vi. that nominee who has received the largest number of first preference votes shall, if that number constitutes an absolute majority of votes, be elected;
- vii. if no nominee has received an absolute majority of first preference votes, the scrutineers shall make a second count;
- viii. on the second count the nominee who has received the fewest first preference votes shall be excluded and each ballot paper counted to that nominee shall be counted to the nominee next in the order of the voter's preference;
- ix. if any nominee then has an absolute majority of votes that nominee shall be declared elected, but if no nominee then has an absolute majority of votes the process of excluding the nominee who has the fewest votes and counting each of the ballot papers to the continuing nominee next in the order of the voter's preference shall be repeated until one nominee has received an absolute majority of votes and such nominee shall then be declared elected:
- x. if on any count two or more nominees have an equal number of votes and one of them has to be excluded that nominee amongst them who had the least number of votes at the end of the preceding count shall be excluded and if such nominees had an equal number of votes at all preceding counts the Returning Officer shall determine by lot which of them shall be excluded;
- xi. a ballot paper shall be informal and rejected if the voter has failed to indicate the number of preference in respect of the name of any nominee.
- (g) An 'absolute majority of votes' means a greater number than one half of the whole number of votes which are cast.

25.14 It was **Resolved by Consensus** that the Synod:

- (a) Endorses the decision of the Business Committee that Yarning Circles will perform the function and meet the requirements of small groups as referred to in the manual for Meetings.
- (b) For the purposes of the 38th Synod, the small group leader/facilitator of the Yarning Circle is named the Wayfinder. This reflects their task as assisting in discerning a way forward, creating a safe space for speaking, conducting business, and building Christian



community as members share the life they have in Christ.

- 25.15 It was <u>Resolved by Consensus</u> that the Synod endorses the decision of the Business Committee that General Proposals were to be submitted by 4.00 pm on Monday 10 March 2025.
- 25.16 It was **Resolved by Consensus** that the Synod receive the written reports contained at R00 R16
- 25.17 It was <u>Resolved by Consensus</u> that the Synod authorises the General Secretary to convey greetings on behalf of the Synod to other Synods within The Uniting Church in Australia.
- 25.18 It was <u>Resolved by Consensus</u> that the Synod authorises the Moderator to convey a greeting to the State and Federal Governments.
- 25.19 It was <u>Resolved by Consensus</u> that the Synod authorises Rev Bruce Moore (Moderator), Rev Dr Adam McIntosh (General Secretary) and Rev Brian Hoole (Business Committee Convenor) to confirm the Minutes of the 38th Synod.
- 25.20 It was <u>Resolved by Consensus</u> that the Synod adopts the Memorial Minutes as presented concerning ministers who have died since the 37th Synod and notes the ministers who have retired permanently and receives a minute of appreciation for each.
- 25.21 It was <u>Resolved by Consensus</u> that the Synod that any business not dealt with on the floor of the synod, will be referred to the Synod Standing Committee pursuant to Regulation 3.7.4.1(d and e)
 - (1) The SSC is empowered:
 - to act on behalf of the Synod between ordinary meetings of the Synod in relation to all matters that are the responsibility of the Synod, except such as the Synod may determine; (clause 36 of the Constitution; regulation 3.7.4.1(d));
 - ii. to deal with matters referred to it by the Synod; (regulation 3.7.4.1(e)); and
 - iii. to exercise the powers, and fulfil the responsibilities, as provided for in the Synod By-laws.
 - (2) In exercising its powers and fulfilling its responsibilities, the SSC must have regard to the following guiding principles:
 - i. focusing on the strategic and policy issues of the Church;
 - ii. engaging in competence-building activities for its members;
 - iii. efficiency and timeliness in approvals and decision-making.

(b) authority be given to the Moderator and General Secretary to vary the dates and times of the Synod Standing Committee meetings if necessary.

General proposals

General Proposal 1: Renewal and Growth: Shared Ambition and Strategic Foundations

- 25.28 It was **Resolved by Consensus** that the Synod:
 - Reaffirm the Shared Ambition, first outlined in Project Plenty and adopted at the 35th Synod, until 2028, at the 40th Synod:
 "One church active in every Queensland community, bearers of Christ's offer of life in all its fullness. Through our shared life we are committed to a flourishing future for
 - 2. Adopt the following five strategic foundations to align the Synod with the "Renewal and Growth" Strategy of the Synod Office:
 - a. Mission Renewal and Growth
 - b. Flourishing Presbyteries
 - c. Forming Leaders

- d. Fit For Purpose Governance
- e. Stewarding Resources
- Note that an annual report to the Synod Standing Committee (SSC) and a report to each Synod in Session shall be received on the progress of the Renewal & Growth Strategy until 2028.
- 4. Note the final Plenty Report included as background to this Shared Ambition and Strategy proposal.



General Proposal 2: Church Planting, Re-Planting & Revitalisation

25.29 It was **Resolved by Consensus** that the Synod:

- 1. Adopt the Church Planting, Re-planting and Revitalisation strategy outlined at Appendix 1.
- 2. Request its boards, committees, and commissions to prioritise and consider resourcing and actions in support of the Strategy.
- 3. Request the General Secretary to prioritise operational planning and resourcing of the Synod office in support of the strategy; and
- 4. Request the General Secretary to collaborate with presbyteries to provide a joint update regarding this strategy to the 39th Synod.



General Proposal 3: Resourcing Renewal and Growth

25.30 It was **Resolved by Consensus** that the Synod:

- 1. Instructs the Synod Standing Committee (SSC) to do all things necessary to establish, in alignment with the guiding principles, a:
 - Property Proceeds of Sale Policy,
 - Church Renewal Fund, and
 - Covenant Ministry Fund.
- 2. Amends clauses 2 and 4 of the Mission Development Fund (amendments in yellow):

Clause 2 Current Reading:

2. Application of this policy

- 2.1 This policy shall come into effect as at 15 May 2022 determined by the Synod.
- 2.2 This policy shall apply to all major sales of property (Reg. 4.1) held in the name of the Property Trust, where the responsible body is a Congregation, Presbytery, or the Synod.
- 2.3 Subject to the Regulations (Reg 4.8), the sum of the net proceeds from a property sale where the responsible body is a Congregation, Presbytery, or the Synod, shall be deposited into the MDF.
- 2.4 The sum of the net proceeds from a property sale shall be held in the MDF on behalf of the responsible body for a period of up to seven (7) years.
- 2.5 Interest may be paid and credited to the proceeds at an agreed rate not exceeding the maximum set by the Synod Property Board.

Clause 2 Proposed Reading:

2. Application of this policy

- 2.1 This policy shall come into effect as at 19 May 2025 as determined by the Synod.
- 2.2 This policy shall apply to all major sales of property (Reg. 4.8) held in the name of the Property Trust, where the responsible body is a Congregation, Presbytery, or the Synod office.
- 2.3 Subject to the Regulations (Reg 4.8), the law and the terms of any special trust, the sum of the net proceeds from a property sale where the



responsible body is a Congregation, Presbytery, or the Synod office, shall be deposited into the MDF.

2.4 In relation to property held by the Property Trust on a charitable trust for the Church's general charitable purposes, the 38th Synod (May 2025) discerned that 10% of the net proceeds of property sales is to be credited to the capital balance of the Church Renewal Fund (specified fund) and 5% of the net proceeds of property sales is to be credited to the capital balance of the Covenant Ministry Fund (specified fund).

2.5 The 15% allocation to the two specified funds will not be charged if the 'sale' is a transfer of the status of Responsible Body from one Church entity to another Church entity, as legal title remains in the Property Trust.

2.6 The Synod Property Board has discretion to NOT charge the 15% allocation to the specified funds upon consideration of a timely application (which would normally be expected in the submission to sell the property)

2.7 The decision of the Synod Property Board is final regarding any application for not charging the allocation to the specified funds

2.8 If the Responsible Body chooses — a higher percentage of net proceeds can be allocated to either or both specified funds mentioned in clause 2.4 — noting that any further contribution will be credited to the capital balance of the funds. The Responsible Body must advise the FIP Board in writing of their decision to vary the standard 10%/5% allocation

2.9 The sum of the net proceeds from a property sale shall be held in the MDF on behalf of the responsible body for a period of up to seven (7) years.

2.10 Interest may be paid and credited to the proceeds at an agreed rate not exceeding the maximum set by the Synod Property Board.

Clause 4 Current Reading:

4. **Applying to use funds held in the MDF**Any Congregation, Presbytery, or the Synod, may seek access to the fund



for projects which are aligned with the missional priorities of the responsible body and all other relevant entity and:

- a. Support or fund capital development and/or strategic innovation opportunities for the church; and/or
- b. Produce a financial return on investment and/or strategic mission benefit to the church.

Clause 4 Proposed Reading:

4. Applying to use funds held in the MDF

Any Congregation, Presbytery, or the Synod office, may seek access to the fund for projects which are aligned with the missional priorities of the responsible body and all other relevant entity and:

- a. Support or fund capital development and/or strategic innovation opportunities for the church; and/or
- b. Produce a financial return on investment and/or strategic mission benefit to the church.
- c. Responsible Bodies can choose to transfer any or all of their MDF balance to either of the specified funds (Church Renewal Fund / Covenant Ministry Fund) upon providing a minute to the FIP Board. Responsible Bodies with existing MDF balances can do so noting that any balance transferred to a different specified fund is no longer tagged to that Responsible Body it is available for distribution to any entity in the Queensland Synod that meets the criteria set out for distribution.

Moderator Elect Nomination

- 25.31 It was **Resolved by Consensus** that the Synod:
 - R1. Note the recommendation of the Moderatorial Candidature Task Group (MCTG) that Rev Bruce Moore be the sole candidate put to the members of the 38th Synod for the position of Moderator elect for a second term as Moderator of the Uniting Church in Australia Queensland from the 39th Synod to the 41st Synod.
 - R2. Note that if elected at the 38th Synod, Rev Bruce Moore will serve as Moderator of the Uniting Church in Australia Queensland for a second term.
 - R3. Note that a ballot for a second term as Moderator will be conducted by secret ballot with the proposal requiring not less than 65% support of ballots received for the proposal to pass.

Rev Barry Cox

What can we really say about Barry Cox?

Barry has been one of those people who typify the Carpentaria Presbytery. Resilient, resourceful, humorous, forthright, insightful, passionate and funny. Barry has been an indomitable part of the North Queensland and Carpentaria Presbyteries ever since he told placements at his exit interview that he had to live within three hours of Brisbane... a flight from Weipa to Brisbane is just a smidge over three hours!!

Barry's placements in Weipa, Townsville Central, Townsville Hospital, Presbytery Minister Admin and back to the Townsville Hospital will never go unnoticed. Because Barry always understood what it means to be available to the whole church as part of his Ordination vows. Serving with diligence

on the Presbytery Property Committee and Leadership Teams for years helped immensely in forming and strengthening a culture of shared responsibility within the leadership of the Presbytery as well as across the wider Presbytery itself.

As pastoral carer for the Presbytery ordinand students, Barry was nothing, if not pragmatic. A typical phone call from Barry would go something like:

Barry: "How are you going?"

Student: "Well, it's a bit tough at the moment."

Barry. "But, you're still alive then?"

Student: "Yes, but..."

Barry: "Okay, I'll tell the Presbytery you're fine."

He would then report simply to the Presbytery that "Such and Such was fine"

The thing about Barry is that even if there seems on the surface to be a callous disregard, this was so far from the truth. For Barry, there is never any quick fix, any "I'm the Saviour" or "Just leave it to me." In his own powerful way, Barry created the spaces that allowed people to step up or even grow up in their ministry. Because Barry has a compassion that belies his "Don't tell me your problems" quip. And he is never afraid to speak up or stand up in the face of opposition to speak truth to power. In his ministry, Barry has stood up to Presbytery Ministers, Moderators, bullying Church Councils and Ministers and the occasional General Secretary. He never runs from a fight, but engages with a true Christ-heart that encourages others to take responsibility for their own actions. Sometimes this would make him less than popular with some. And whenever people walked away from a encounter with Barry scratching their head, wondering what on earth he is on about, all too often they would come to see the situation in a new light. For Barry, it's never been about popularity. It's always been about God.

Barry understands that the primary purpose for the church is to make disciples. And that all we do should be focused on that goal. He understood the complexity of church politics and would throw himself into the mix if the result would be a better church. And he had the insight and strength to evacuate the field of combat if that would bring the best result.

As a non property-expert who took on property, a non-administrator who took on administration and as a non-accountant who took on the treasury, Barry has been diligent and effective, particularly in the lead up to the formation of Carpentaria Presbytery.



But, his years in congregational ministry and chaplaincy have also been a time where Barry has demonstrated his enormous gifts in pastoral care and listening. One phone call from a minister in a far-flung congregation to inform Barry of a hospital patient being transferred to Townsville was all it took to know that he would find them and be with them. A true and faithful companion on the road.

And after all, isn't it the companions on the road that make the journey worth travelling!

Barry, you have well and truly earned your rest. As long as Jenny will let you have some rest. There's always fans to clean, grass to mow, a pool to tend to and heavy objects up on high cupboards.

We also know you'll never stop working for the God you love and the church you have promised to serve. This journey is not over yet.

Rev Peter Elliott

Peter was accepted as a candidate for Minister of the Word in 1989 and after 5 years study at Griffith University and Trinty College attained a Bachelor of Theology and was ordained by the Presbytery of North Queensland on 1 December 1994.

His first placement was to the Isis Parish which included the congregations of Childers, Biggenden, Dallarnil, Woodgate, Coalstoun Lakes, Howard, Torbanlea, and Burrum Heads. During his four years in the Isis Parish, Peter served on the Pastoral Relations Committee of the Mary Burnett Presbytery and as Chairperson of the Presbytery. He also began a Graduate Diploma in Theological Studies which he completed in 2008.


Peter accepted a call to the Redlands Parish beginning in 1999, serving particularly with the Cleveland congregation. Following the disbanding of the Parish, Peter continued to serve for a total of thirteen years with the Cleveland Congregation. Peter then accepted a call to Broadwater Road Congregation in 2012 where he served for over four years. Then followed ministry in the Yeronga congregation in 2016 for four years. Peter began supply ministry with the Victoria Point congregation in 2020 which then became the Redlands congregation following an amalgamation with Redland Bay, Cleveland, Capalaba, and Wellington Point. Peter retired on June 30, 2024.

While serving in South Moreton Presbytery, Peter served for several years on the Pastoral Relations Committee, some of that time as Chair, and as Chairperson of the Presbytery of South Moreton.

Peter's great passions were for good, sound worship and Christ-centred preaching. His teaching gifts were also widely used in leading people in their discipleship of Jesus Christ. Peter's greatest delight was seeing people grow in their faith and discover and use their Spirit-given gifts in service.

Another of Peter's passions was ecumenism. Inspired by the Uniting Church's commitment to deeper unity with other churches, he endeavoured, throughout his ministry, to work with other Christian denominations in the furtherance of the kingdom.





Rev Douglas (Doug) Foster

Doug was born in Rockhampton in 1958. He was schooled in the Gympie area, around Gunalda.

Doug commenced a Degree in Surveying at the then Qld Institute of Technology in 1976.

In the early 1980s, Doug was serving in the Surveyor-General's department in Mackay, and worshipping at Iona West, under the thoughtful leadership of Rev. Dr. Gereldine Wheeler. He gave leadership to the young adults of the Uniting Church in the Mackay area. There he met and married Barbara Miller, and two sons, Graeme and Lindsay were born in Mackay.

Doug candidate through the Central Queensland Presbytery in 1987 and commenced studies in 1988 Brisbane at the ecumenical Brisbane College of Theology, coinciding with the opening of World Expo.

Their third child, Claire, was born while Doug was a student at QCT.

Doug identifies a QCT sponsored visit to the World Council of Churches 7th Assembly in Canberra as a highlight of his time at QCT. This visit included attending a School of Ecumenical Theology, and the Visitors' Program to the Assembly.

After ordination in 1991, moved to Mareeba Parish early 1992 and served there for 5 years. 1992 was the 50th anniversary of significant WWII events, and Mareeba had been an important staging post. So it proved to be a great introduction to the community.

In 1996, Doug undertook an exchange with a Methodist Minister, Rev Roy Howard. The family lived in Camberley in the UK, where he served in High Cross Church, and Sandhurst Methodist Church. An amazing cultural experience.

Returning to Mareeba for the remainder of 1996, the family relocated down the road to the Northern Beaches area of Cairns, where he served as a church planter at Northern Beaches and Freshwater Uniting Churches. In order to precipitate a new church presence, he went to a part-time placement in 2000. It was great time of challenge, hope and renewal as the Church, with minimal resources, engaged actively with the local community and grew to support a full-time placement by 2007.

In 2002, Doug commenced as a part-time Police Chaplain, eventually looking after the greater Cairns area. He was successful in being placed into a full-time Police Chaplaincy position that was created in 2009. This covered the Far North of the State, and provided many opportunities to both support the Police, and also the community during some tragic events.

With both part-time and full-time, Doug served in that Chaplaincy position for 22 years.

Doug fulfilled his commitment to the wider church, by serving on various positions across the Presbytery and Synod, and continues in the role as Chair of the Synod Committee for Counselling.

A strong call to support the wider Synod came in 2023 when he and Barbara relocated to Brisbane to undertake the role as Ministry Agent Coordinator. In addition to providing Chaplaincy support to the Synod Office, the role consisted of supporting Uniting Church Chaplains across the State, and an administrative role helping revisit various policies and procedures around ministry within the Synod. Following the cessation of Public Hospital Chaplaincy support, it seemed an appropriate time to join Barbara in retirement.



Doug and Barbara have returned to Cairns to once again connect with family.

Doug's ministry is remembered for innovation and exploration of new opportunities for the gospel, alongside a quiet purposefulness and calm pastoral presence. His long term placements as a Police Chaplain is testimony to his capacity to form quality professional and pastoral relationships.





Rev Garry Hardingham

What can we say about the Rev. Garry Hardingham's ministry in the Uniting Church:

Carpentaria Presbytery/Presbytery of Calvary & North Queensland?

The region met the Rev Garry Hardingham in 2001, when he arrived in Mount Isa to take up his placement. Prior to this, some may have known him as he worked for Telecom in the Northern area. Now nearly 24 years later here we are saying farewell. So, what can we say about Garry's ministry?

He was Mr Fixit – he could, mend, adapt and build not only planes, but cars, websites, homes and remodel Presbyteries. He received a Special Achievement Award, from the Governor-General, Her Excellency Quentin Bryc AC, for the work he and the Nambour Uniting Church youth did rebuilding airstrips after the 2010 floods. He also received an Order of the Outback from the Burke Shire. In the time of Rev Barbera Bailey, the Presbytery had a long weekend bus trip to Mt Isa where we met the congregation and had a church service. Here we found Garry had the words of hymns scrolling down the screen whereas other churches changed sheets on Overhead Projectors. His time at Telecom produced many exciting developments in the Presbytery.

Maybe, he should be called Mr Networker, as he had been a member of so many organisations and committees and had knowledge of many more. He was Secretary of The International Rural Churches Association (IRCA), a committee member of Frontier Services, has been on numerous Synod and Assembly committees, not to mention a good number of years on Presbytery Leadership Team, the many Consultations and Placements he was involved in.

In 2015, when Justice Henry did the Welcome Address for the opening of the Law Year Church Service, he conveyed his sincere gratitude to Reverend Garry Hardingham for hosting the service. So, it seems, he always seems to know a person who knows a person and the benefit of that, was that Garry could always find someone to fit into our Presbytery.

Maybe, we should call him The Influencer. He gave tireless energy to keeping in-contact with so many people around Australia and the world. He spent many years criss-crossing North Queensland by four-wheel drive when based in Mt Isa. Then he moved to Cloncurry, and he began flying MJZ, The McKay Patrol Cessna. As a Presbytery Minister he went further afield to Brisbane, Sydney, Melbourne etc by commercial airlines. Then somehow, he also had time to build his own plane, LDV Morgan Aeroworks Cougar which took him to Thursday Island, Mornington Island, Napranum etc. Yet, back in our Presbytery who hasn't had one of Garry's surprise visits on Sunday morning at church – a time to catch up and have a chit-chat. So many contacts, so many circles of influence.

Maybe, another title should be The Logician, as he was always reflecting on the old ways and strategically thinking about new patterns to take the Presbytery forward. Who can forget the daily devotional '40 Days of Fitness'. He also re-wrote the Constitution for IRCA, was instrumental in remodelling the Presbytery and if you had a drone and flew it over his house at 5am, there you would see Garry on his back deck contemplating, cogitating and deliberating on the next action for the Presbytery and Church. Hence, some of us who have worked with Garry, cringe when he turns up with a new idea, because we knew we would get the task to try and not only implement it but flatten out the kinks before it was put into action.

There is no denying that to be a Presbytery Minister, there are many elements required to ensure the smooth working of the Presbytery i.e. networking, influencing, contemplation and sometimes having to work in



restoration. The presbytery minister sometimes has to have compassion and a sensitivity while at the other end of the spectrum there needs to be hardness, a coolness and objective perspective to bring about change.

It must also be noted, that Teresa, Garry's wife has contributed more than any of the Presbytery will understand. She accompanied him on endless flights and drives, has been not only his companion and sounding board but shouldered the responsibility of keeping the family going when Garry was called so many times elsewhere on Church matters. We wish to formally acknowledge Teresa in Garry's ministry and mission and say thank you.

So, what one thing could we say that would sum up Garry's ministry in the Presbytery – he was a 'Change Agent'. The Presbytery has been remodelled from the Presbyteries of Calvary and North Queensland into the Presbytery of Carpentaria. It has been refocused on mission, reinvigorated to do the work Christ sets before it and re-energised through many of Garry's ideas and the many people he personally inspired who were called to serve.

In Matthew 25:14ff we have the story of the five bags of Gold. The master gives one person one bag, another two and another five. When the master returns, he rewards the ones who have used their talents and gifts to grow what was given to them. The master says "Well done, good and faithful servant! You have been faithful with a few things; I will put you in charge of many things. Come and share your master's happiness!"

The story is about being invited into the mission of God and giving your all to grow the Kingdom. Hence, the work we do is not our work but God's. God gives us chances and we respond to the task. Garry over the years was given more and more responsibility and he responded by doing his best. From being called into God's work at Malanda, going through theological college, being placed at Mt Isa then Cloncurry, being called to be one of the Presbytery Ministers and then taking on the responsibility of working with Calvary Presbytery. Garry has done his best and we can ask no more of anyone.

It was interesting to note, that in the Scripture passage, there was a season for the completion of the task. The master went away and then returned. The servant was rewarded for multiplying the bags of gold. Yet the work kept on going and what the servant was able to do was to share in the master's happiness.

Well one door has closed as you finish as a Presbytery Minister and nevertheless another one will open as you retire. We all would like to congratulate you for being a faithful servant. Yet, as the Scriptures described, there is more to do - Christ continues to challenge us to share the Good News and be part of a community that needs change. Whether we are Ordained or Lay, employed or retired, God still uses us.

To quote, Garry himself:

"Little realising that in the Presbytery, Synod and Assembly office your name is instantly placed into the "Fools we can use" file and you find yourself on Synod committees and Assembly agency support teams and Pastoral Relation Committees or being asked to single-handedly represent the Uniting Church at the next visit of the Pope."

We are 'Fools' to be used for Christ. So may you, Garry and Teresa, be blessed in your retirement and continued work for Christ. May the Spirit continue to bless you, your family and whatever and wherever you may be led to next.

May the master's happiness continue to envelope you both. Amen.

Rev Tom Kerr

Tom was not raised in a Christian family and as a teenager he came to faith through the mission of a local church in his neighbourhood. He became involved in the church's ministry with young people and this commitment to positively shaping the lives of young people eventually led to fulltime ministry.

After completing his training to become a Primary Teacher he felt that this career was not exactly what he desired and went on to study youth ministry. In 1981, he graduated from the Youth and Education Diploma course at Alcorn College. During this training, he completed field placements at Beaudesert parish and at Wellers Hill Tarragindi congregation. After completing his study, he spent another year at Tarragindi before accepting a job at The

Gap Uniting Church where he served as the youth worker from 1983-1998. It was here that his ministry with youth and young adults flourished and his impact on the lives of many over these years is immeasurable.

Tom served as Regional Youth Worker with Aspley, Sandgate, Bald Hills and Bracken Ridge Uniting Churches from 1998 – 2001 before accepting a position with the Youth and Children's Ministry Unit (YACMU) as Early Adult Ministry Consultant which encompassed a role as 'TEA Party' alternate Faith Community leader at Toowong Uniting Church.

In 2009, Tom was ordained to the Ministry of Deacon which complemented his calling to serve God in ministry with young people and those at the margins of the church.

When YACMU closed, Tom took on two part time roles, one as Vocational Trainer with Scripture Union Qld/Australia 2010 - 2023 while also working as National Faith Development Consultant, (Youth and Young Adults) for the Assembly from 2010 - 2017.

Tom enjoyed his life beyond his vocation. He maintained a keen involvement in Jui Jitsu, was an instructor with a local P.C.Y.C. group for more than 20 years and completed his 2nd Dan Ju Jitsu Black Belt in 2008. Tom is a keen surfer, passionate artist and published author of several books. In retirement, he has created "Life Island" a resource for wellbeing and community building, led ministry retreats and continued support for school chaplains, counsellors and ministers with this new ministry tool.

To know Tom Kerr in ministry is to know a deeply thoughtful and kind-hearted man with a cheeky laugh and boundless sense of humour. He brings energy, life and fun to every gathering and positively changes the dynamic of each meeting in which he is involved. You just feel better with Tom in the room. His ministry has been an inspiration to his colleagues, particularly in youth ministry, over many decades. Whether it be the resources he wrote, the crazy games he invented, the training and coaching he provided, or the thoughtful leadership he nurtured, Tom's impact rippled throughout the life of the Uniting Church across the nation.

Tom's reflection

My greatest thrill in ministry has been helping young people deepen their relationship with God. Whether the next step they take is as simple as deciding to try praying for the first time, through to making a commitment to serve God in full time ministry, it has been a great joy and privilege to be invited to share in their spiritual development.

Just as fulfilling has been the years spent equipping leaders and youth workers for roles in School Chaplaincy, church youth work and community Youth Work.



I am eternally grateful that God has given me so many wonderful opportunities to serve as a Youth Worker and as a Trainer of Youth Workers. I have been a Youth Worker with the Uniting Church in Australia for 38 years in local, regional, state and national levels of service. Overlapping the last era of service, I was also a Vocational Trainer helping youth workers and chaplains attain the Certificate 4 and Diploma of Youth Work with Scripture Union's Training Institute.

Forty-four years of ministry and mission to children, youth, families and young adults, and training those leaders and professionals who would support them, has been my life vocation.

For me, this has meant participating in youth ministry in various ways including developing systems to build bridges in to the life of the church through youth ministries, equipping others for ministry; resourcing ministry and mission at congregational, presbytery and synod levels; evaluating redesigning and strengthening the effectiveness of ministries at all levels, and some ministry with young adults and youth workers at the national level.

My ministry has often involved dreaming new dreams and creating new realities. It has included effective change management and ongoing support for projects once they have been established.

I am also ever so grateful to my wife, Anne; daughter Katelyn and son, Tim, for their support, encouragement and countless sacrifices that have enabled me to serve the church and the community across those decades, in my youth worker roles.





Rev Dr Anita Monro

Rev. Dr Anita Monro was baptised as an infant in the Methodist Church by her grandfather, Rev. Samuel George Monro. In 1973, at an Easter Junior Christian Endeavour camp, she experienced a deep sense of the abiding parental love of God and made her commitment to follow Jesus. She was confirmed as a member of the Uniting Church in March 1978 at Wavell Heights Uniting Church.

At a YAF rally in December 1978 where candidates for ordained ministry spoke, Anita experienced a profound sense of call to ordained ministry; and from that point worked towards that goal. Mentoring by Rev. Dr Elizabeth Nolan during Anita's teenage and early adult years introduced her to worlds of biblical and theological scholarship that nurtured Anita's faith.

After completing high school, she took a year off study and worked for the Uniting Church Foundation & Investment Board of the Qld Synod. She then completed a Bachelor of Arts at The University of Queensland, majoring in Religious Studies, Sociology and English Communications. During the final year of her undergraduate degree, she candidated through the Presbytery of North Brisbane, entering Trinity Theological College in 1986 to undertake a Bachelor of Theology with a double major in Scripture through Brisbane College of Theology (BCT). She met her husband-to-be, Russell Morris, at Trinity.

In 1988, Anita completed her student placement year at West Toowoomba Parish, Presbytery of The Downs, supervised by Rev. Paul Moore. With Rev. Dr Paul Walton, she was ordained on 10 December 1988 in a joint service of the Presbyteries of North Brisbane and The Downs at St Stephen's Uniting Church in Toowoomba. Anita's exit placement was for 12 months to Home Hill Parish in the Presbytery of North Queensland while Home Hill and Ayr were moving to become the Burdekin Parish at the end of that year. Cyclone Aivu devastated the small town at Easter that year and the remainder of the year was spent re-building from the disaster.

On 25 November 1989, Anita and Russell were married at Clayfield Uniting Church on the site of the Wooloowin Methodist Church where her parents had been married 28 years previously. Russell and Anita entered a joint placement in Maryborough Parish from 1990 to 1992. In Maryborough, they served with colleagues from both the Anglican and Roman Catholic churches who had all studied together at BCT. While at Maryborough, Anita completed an Honours degree in Religious Studies by distance education through Deakin University.

From 1993 to 1996, Anita took study leave to undertake her PhD through the Griffith University School of Theology, the postgraduate research arm of BCT. During that period, Russell was minister in placement at Stanthorpe Parish in the Presbytery of The Downs.

Her PhD studies were undertaken in philosophical theology under the supervision of Drs Elaine Wainwright RSM and Francie Oppel. Her thesis entitled "Subjecting Ambiguity: Towards a Feminist Poststructuralist Theological Methodology" included chapters addressing biblical interpretation, theological imagery for God, and Christian community development strategy.

While on study leave, Anita convened the Program Committee of the 'Women Clothed with the Sun,' the 3rd National Gathering of Women in The Uniting Church in Australia. Anita designed and coordinated the innovative program strategy which was subsequently included in her thesis. A significant, ground-breaking piece of her thesis also was presented to the Uniting Church's Assembly Task Group on Sexuality.

Towards the end of her study leave, Anita began editing and writing study materials for Coolamon College and undertook some supply ministry for Warwick Parish. When Russell was asked to become the General Secretary of Queensland Churches Together, Anita was offered a part-time placement with Coolamon College as



Educational Developer. Over the next 5 years, Anita filled a range of roles with Coolamon, including Dean of Postgraduate Studies involving the setting up of the Coolamon postgraduate program within Sydney College of Divinity (SCD). She became Acting Principal in 2002 and negotiated the transfer of Coolamon College from BCT and SCD to Adelaide College of Divinity. In 1999, Anita had provided supply ministry for Geebung Congregation in the Presbytery of Moreton Rivers; and for 2001, she served half-time as Director of Gospel & Gender, another agency of the UCA Assembly.

From 2003 to 2008, Anita was Lecturer in Liturgy and Theology at United Theological College in Sydney and Charles Sturt University School of Theology. In 2009, she was called to be minister of Armidale Congregation in the Presbytery of New England North West in the Synod of NSW & ACT.

In 2013, Anita returned to the Qld Synod to become Principal of Grace College at The University of Queensland for ten years. During Anita's tenure as Principal, she reformed the College's suite of policies, including mission and values statements, risk management and strategic development plans. Anita prepared beautiful inclusive liturgies for weekly Community Dinners at Grace as well as for all special College events such as the Welcome and Valedictory services for students. She initiated and hosted monthly ecumenical Women's Theology seminars for churches in Brisbane area and in 2015 and 2016, five-day residential Women's Theology Conferences which attracted international and interstate speakers and workshop leaders. Anglican, Catholic and Lutheran women pursuing ministry studies particularly appreciated her mentoring and leadership in feminist theology.

During this placement, despite some serious health issues, Anita undertook a Graduate Certificate in Business (Philanthropic and Not-for-Profit Studies) through Queensland University of Technology and became a Graduate member of the Australian Institute of Company Directors. Anita successfully managed the Covid pandemic period for the College 2020-21, keeping the College open for interstate and international students especially, and providing emergency hospitality for other UQ students from other colleges to enable those colleges to continue to function. From 2021 to 2022, she facilitated a smooth transition from the college housing women only to being gender-inclusive, an innovation particularly appreciated by the UQ Senate. The 're-brand' and renovations allowed Grace College to become financially secure with a full complement of students again from 2023.

Anita moved into semi-retirement in 2023, undertaking some teaching in Religious Studies at the University of Queensland and Theology at St Francis Theological College (Anglican) as part of the University of Divinity. From late 2023 until December 2024, she also provided Supply ministry for her local congregation, Blackall Range, in the Presbytery of Mary Burnett.

Anita was a member of the Assembly's Liturgy Commission from 1994-1997 and the National Working Group on Worship from 2002-2010. She participated in the development of *Uniting in Worship 2* with a particular focus on advocating for the inclusion of lament and diverse imagery for God. Anita was a member of the Uniting Church delegation for the joint UCA-Anglican dialogue (1998-2001) which produced "For the Sake of the Gospel" addressing potential stages towards unity across the denominations. In 2012, she was nominated for President of the UCA Assembly.

She served on a range of other ecclesial and organisational committees including the establishment of the Dostana Board for fostering the relationship between the Uniting Church's Qld Synod and the Diocese of Amritsar in the Church of North India. In 2022, she represented Dostana at the Diocesan Synod and spoke at their annual Youth Conference.

Over the course of her scholarly career, Anita provided keynote addresses in various scholarly contexts including the 3rd Beverly Bellinger Memorial Lecture for the Synod of Victoria in 2001, and the 2009 Sydney conference of the international association, *Societas Liturgica*.



Anita's publications include a monograph from her doctoral thesis; 2 co-edited collections on Public Theology and worship in Australia; more than 20 scholarly articles across the disciplines of biblical interpretation, systematic theology, practical theology and feminist methodology; and numerous educational and liturgical resources.

Rev Dr Anita Monro has lived and modelled an educated, informed and practical faith for a complex and diverse contemporary world. As a creative innovator, her scholarly work and leadership has not always been welcomed or appreciated by some leaders of the church and yet she has remained committed to the God of overwhelming Grace and Love, fully revealed in the incarnate Christ, and made present continually by the power of the Holy Spirit. We give thanks to God for the faithful, diverse and creative ministry of Anita and wish her well in retirement.





Rev Beth Nicolls

Right from high school Beth was encouraged to share her faith and creativity within the life of her home church in Yeppoon. After moving to Brisbane, boarding at Methodist Training College and Bible School where she met husband George, Beth completed the Lay Preachers Course while studying Fine Art at Queensland College of Art. These were faith forming years: living in a Christian community and participating in Weekends of Witness were significant.

After completing Art College, the principal of Alcorn College said "Beth, I think you're called to be a youth minister". For Beth a lot of things fell into place, and she applied and was accepted into the 3rd intake of YEA (Youth Education Assistants) course in 1978. Beth also married George that year and was appointed to Aspley Parish as Youth Worker.

As a Youth Worker and then Specified Minister of Youth Worker, Beth found her creative niche in children's and youth ministry, not only doing craft, but in creative worship, Messy Church, Intergenerational and Pioneer ministry and helping others to imagine and implement different forms and styles of being church and creating spaces where God could be encountered and known. This included helping to establish a Community Centre at Flagstone, and for 9 years, 1985-1993 as the Synod's craft consultant helping churches establish craft ministries. Beth's passion for photography enabled the establishment of the Photography Club in the Redlands UC, and as a leadlight artist making and restoring windows in some of her placements.

A significant part of Beth's ministry was in encouraging others. Her commitment to supporting and training leaders and helping the church: locally, Presbytery, Synod and Assembly wide - to engage in youth, children's a family ministry, was a mark of her calling. When the church Assembly recognised Youth Work as a Specified Ministry in 1995, the Synod Youth Worker Training Committee was formed to oversee Youth Worker training in Queensland. Beth served on this committee including chair for many years, advocating for Youth Ministry, training, and mentoring students, until the last youth worker was commissioned in 2011. In 2008 the Assembly moved that those in Specified Ministry of Youth Worker could transitioned to MOW or MOD. Beth had prepared for the inevitable transition by completing a Master of Ministry 2005. She was ordained in 2008 as a MOW at Cleveland. Beth was very sad for the church when the Specified Ministry of Youth Worker training disappeared but continues to claim her speciality in Youth Children and Family Ministry even as a MOW.

Camping has also been a big part of Beth's ministry: Presbytery, Synod and Congregation Youth and Children's camps: Day Camp, Funfari, Easter Camp, Summer and Easter Madness, Youth Study camp, KUCA camps, Family Camp, Kids Camp Out, Discoveries Camp, Young Adults January Camp, yearly Young Adults Ski trips (YASKI) and taking young people to NCYC Nationals Christian Youth Conventions all over Australia, and on Go West mission trips to Western Queensland. All to help young people, children and families to know Jesus, to grow in faith and give a broader experience of church and to encourage other churches.

Beth with George served as a Youth Worker from 1978 (while a YEA student) at Aspley/Bald Hills/Albany Creek & Clayfield Hamilton Parish; and as a qualified Youth Worker 1981 at Stafford/Stafford North Parish; 1985-1993 DCE Craft Consultant Qld Synod; 1994 Specified Minister of Youth Worker (commissioned 1995) at Sandgate; Youth and Children's Ministry Unit; 1997-2013Redlands Parish and also as MOW (ordained 2008) at Cleveland, Victoria Pt, Trinity Wellington Pt and Thorneside Churches; 2013-2021 Project Officer Mission in South Moreton Presbytery; finishing her ministry back with a 3 year short-term placement at Redland UC with Trinity Wellington Point and Capalaba. Completing 46½ years of ministry.

Beth is forever grateful for her family, for husband George and daughters Claire and Emma. As a family they were involved in many aspects of ministry. George led youth groups, Bible Study groups and helped on camps and ministry. Claire and Emma were initiated into ministry through Craft Ministry, where right from babies they



would travel with Beth while she taught and helped groups all over Queensland. In Parish and congregational ministry, as Claire and Emma grew older, they were leaders for Youth Group, P1, music groups, camps, Go West and Easter Camp and Easter Madness, NCYC. Claire was a Day Camp director for many years. George worked at The University of Queensland for 35 years where Emma, Claire and Beth also attended to study. 'My family have been such a support and wonderful blessing – I do give thanks to God for them.'

Reflection.

Early on at a College Retreat I was challenged by Ephesians 2:19 'So then, you are no longer strangers and aliens, but you are fellow citizens with the saints and also members of the household of God'. This became a guiding principle for my ministry. Not only was I accepted into this remarkable family, but I was called to encourage others to know the loving acceptance of God. I was blessed to be able to do that throughout my ministry, and especially with youth and children and with some wonderful leaders. It inspired my commitment to do what it takes to help young people hang in there with the church until their faith kicked in. This became my mantra, and with God's help and leading it gave me the confidence to try new things and to go to places I could not have imaged.

I can say as I retire, I have been richly blessed – and I would do it all again! God is good all the time – all the time God is good.

Rev Kaye Ronalds

Kaye Ronalds was ordained in Rockhampton on the 9 March 1984 along with Dennis Harth and Bruce Johnson. All three were exit students taking up placements in the Presbytery of Central Queensland. Her husband, Owen, was an electrician and while in Rockhampton he gained his contractor's license,

Kaye had responsibility for two suburban congregations – Wandal and West Rockhampton plus two small country congregations – Bushley and Westwood. After three years (1984-1986) she took some leave to have a family and moved back to Brisbane.

Ellen was born in 1987 and Naomi was born in 1989. Around 1992, Kaye applied to become a part-time Chaplain in the Australian Army. She was the first woman appointed as a Chaplain in the Australian

Army. Rev Wendy Snook had been appointed as a Chaplain in the RAAF a couple of years earlier.

For two years, 1995-1996, Kaye worked at Kenmore State High School as the inaugural Chaplain.

After ten years away from ministry in a congregation Kaye was called to the Capricorn Coast congregations of Yeppoon and Emu Park.

Kaye continued to do part-time chaplaincy with the Army including Annual Camps with the Australian Army Cadets, three months serving on Lavarack Barracks in Townsville (Feb -May 2000) and a "yo-yo" deployment to the Solomon Islands spending one week per month from July 2005 – January 2006.

Twice, Kaye filled in when the Presbytery Minister was on long service leave and when there was a vacancy in that role.

In February 2006 Kaye took up the role of Presbytery Minister for Central Queensland – from Proserpine to Tannum Sands north - south, and west to Winton. That involved supporting ministry agents and congregations to be effective in mission in their communities. Organising consultations, seeking to match ministry agents with placements, chairing meetings and supporting lay leaders as many of them stepped up when there were long vacancies.

The Synod elected Kaye as the Moderator so Owen and Kaye moved back to Brisbane in order to prepare for the role in January 2011.

For a few months she was supply minister at Indooroopilly Uniting Church.

Inducted as Moderator in October 2011 serving until October 2014.

A new call into congregational ministry began with her Induction in January 2015 into Granite Belt congregations – Stanthorpe, The Summit and Severnlea. The Summit celebrated its Centenary in 2017 and the closed the Congregation a few months later. New initiatives in the Uniting Churches on the Granite Belt included the launch of the Blue Care Grief and Loss Support program in 2016 and the Retreat Walk which has become a regular feature of the long weekend in May. COVID made an impact in many ways but it did prompt the Sunday Worship on Stanthorpe Uniting Church facebook page.

Since coming to the Presbytery of The Downs, Kaye has served five years on the Scots PGC College Council 2015-2020.



In December 2019, Kaye was appointed as the Uniting Church member for the Religious Advisory Committee to the Service. This part-time role draws on Kaye's experience in governance, pastoral care and identifying suitable applicants for Chaplaincy in the Australian Defence Force.

At the end of May the Presbytery conducted a closure of placement service.

Kaye and Owen will move back to Brisbane and make space for supporting the family.





Rev Dr Pienaar Schalk

As I reflect on our journey together, I count it an immense privilege to have known Rev Dr Schalk Pienaar as a colleague and friend for many years. Our connection began during our shared ministry in the Methodist Church of Southern Africa, where Schalk served as the minister in placement at Northfield Methodist Church in Benoni— a place that holds deep significance for me as my home church and the spiritual home of my parents.

Schalk's remarkable ministry journey began in the South African Air Force, where he served as a navigator and lecturer in Aeronautics from 1973 to

1981. In 1982, he answered God's call to ministry, entering the Methodist Church, being ordained in 1988, and eventually transitioning to the Uniting Church in 2010. His career has been one of extraordinary breadth and depth, encompassing placements in seven churches, including a mega-church of 4,000 members, where he faithfully served as Senior Minister for 13 years.

Since coming to Australia, Schalk has dedicated 14 fruitful years to the Kawana Waters Uniting Church. He has brought exceptional skills in pastoral care, preaching, and small group ministry, always leading with wisdom and compassion. Schalk's academic accomplishments are a testament to his commitment to lifelong learning and theological reflection. Rev Myeong-Hee (Priscilla) Seo

Myeong-Hee Seo and her husband Ji-Won Yu arrived in Townsville in early 2005 on visitor visas. They had come to explore the establishment of a Korean speaking church here. They were being sent from the Korean Methodist Church as missionaries which Myeong-Hee and Ji-Won believed was God's call to them. They have committed themselves 100% to this call over the last 20 years.

Myeong-Hee Seo had a basic level of English, but communication was still not very easy, especially when it came to filling in forms and

applying for visas etc. As a Presbytery we were able to help her through these processes. In order to assist us non-Korean language speakers with her name, Myeong-Hee Seo took the name Priscilla. This was one indication of her large pastoral heart which is evident in all that she has done and continues to do.

Initially Priscilla and Ji-Won were commissioned as missionaries to Australia. She continued her studies while in Australia and was ordained as a minister in the Korean Methodist Church. In May 2020 she received the certificate to officially recognize her as a Minister of the Word in the Uniting Church. This was a special moment for Priscilla.

Priscilla and Ji-Won are people of prayer. Their early morning prayer times at Townsville Central church were very frequent. Prayer is the basis of their life and ministry and God has heard their fervent prayers for their work, church members, family, health and for the wider church and community. They took to heart Paul's injunction in 1 Thessalonians 5:16-17, "Rejoice always, pray without ceasing, give thanks in all circumstances; for this is the will of God in Christ Jesus for you".

Through persistent prayer and an unwavering faith Priscilla, with her husband's strong support have left an important legacy in Townsville and beyond. Below are listed some of those significant ministry achievements.

In March 2007, the Korean Faith Community was established at Townsville Central Uniting Church and that continues to flourish today under the leadership of the Deacons, elders and Pastor Gi-Young Youn who arrived in 2022. There continues to be an important partnership between Townsville Central and Korean Faith Community.

Priscilla saw the need to support seasonal workers in Bowen and established that work in July 2013. She had contacted her church in Korea and in due course Sung-Hee Choi (Deborah) came to assist the planning, then implementation of that pastoral work. Deborah arrived in September 2012 and stayed until she had to leave in May 2017 due to not being able to procure a second religious worker's visa. Under Priscilla's oversight, Deborah also connected with some Korean families in Mackay and held regular Bible Studies, fellowship meals and worship services cooperating with St Pauls Uniting Church in Mackay. Priscilla and Ji Won continued to travel to Bowen every Sunday afternoon during the picking season and also to Mackay after Deborah left.

As mentioned before, Priscilla and Ji Won arrived on a visitor's visa. They were able to help her procure 2 religious workers visa's (2 years each) before they applied for permanent residency. This was granted in 2010. In recent years both Priscilla and Ji Won became Australian Citizens.

In 2019, Priscilla, Ji-Won and their son Peter were significantly impacted by the flooding event in Townsville. They lost almost everything in their home in Idalia. With support from Presbytery and local congregations and their deep faith they overcame that setback and have continued to move forward with God.

Priscilla was able to be a pilgrim on an Emmaus Walk in North Queensland which was I believe a very special time for her. She also has a community and ecumenical heart which showed through her involvement with Stable on the Strand in Townsville, church fetes, ecumenical prayer meetings and the annual Walk of Witness.



Priscilla has not always enjoyed good health. She has travelled to Korea at times for treatment but also for special family times such as the marriage of her daughter and the birth of her grandchild.

It was with much excitement that Pastor Gi Young Youn was able to come to Townsville in 2022 to take over the leadership of the Korean Faith Community. Priscilla and Ji-Won could now relax but as was typical of this woman of prayer and faith, she then sought other ways to serve her God in chaplaincy and other roles. I am sure that she will continue to minister in retirement as God leads.

It can truly be said of Myeong-Hee in true Methodist tradition – Well done good and faithful servant.

We must also never forget the important support role played by Ji Won in the ministry. They are truly a team both in their married life and in ministry. Thank you, Ji Won for your servant heart.

May you both know God's rich blessings in the years to come.

Rev Dona Spencer

Dona commenced her ministry at Southport Uniting Church in 2011, after a 30 year career in Secondary Art Teaching and community Art Work. She initially thought it was 'goodbye art, hello ministry' but was soon to be amazed and thrilled at how ministry and the arts work well together.

Her first ministry placement was for 7 years at Southport Uniting church, during which time Dona co-ordinated, along with a team of volunteers, the "Flourish Arts Festival" on the Broadwater Parklands and at Southport Uniting Church. "Flourish" aimed to take the church out into the community, and the arts into the community, celebrating in love and joy, the creativity of our Creator. She also ran a weekly "KidzArt" programme which drew together parents and children of different cultures and faith.

Following Southport, Dona's next placement was for four years at Kenmore Uniting church, where "ArtBurst" was born, an annual celebration and coming together of artists in the community which continues today. "Touchstones" has also continued - a weekly meditative and mutually encouraging space, where women can share and reflect, and make art together, for personal expression or for the expression of the church seasons in the sanctuary, or for exhibiting with Visionaries, the Christian Art group.

Dona's final placement took her to Maranoa, working as a Bush Chaplain for Frontier Services, Uniting Care Connect 100 and the local churches. Life in the outback was busy and varied and truly inspiring for Dona. A highlight of Dona's ministry there was the oversight of an 8 metre long mural for Wallumbilla State School, where each child's drawing was represented in an aerial view of the landscape, along with flora and fauna and significant land marks.

Dona is retiring to her house in Anstead, full of gratitude for the amazing journey with the Uniting Church, which began twenty years ago, when she answered a call to begin to study Theology at the Brisbane college of theology which became a call into Ministry. We thank God for your graciousness and love which has permeated Dona's journey and experiences.

Rev Dr William (Bill) Adams

Rev Dr Bill Adams regarded the calling to ministry as a wonderful privilege. He saw this role to be perhaps the most rewarding and fulfilling of any that he could imagine. The obvious rewards lay in its central position in human relationships, placing the minister where he might share in the most basic and essential of all human interactions, with family, with friends, with colleagues, with those of similar conviction and with those of opposite opinions, with scholars and with humble folk, with old people and young, with the wider world.

Born on June 10, 1930 in Five Dock, Sydney to William Henry Adams and Edith Margaret (nee Duncan), Rev Dr Adams attended Sunday

School at Five Dock Presbyterian and Five Dock Methodist Church. He completed his high school years at Fort Street Boys' High from 1943 to 1947, and in 1948 and 1949, Rev Dr Adams attended Sydney Teachers' College.

From 1950 to mid 1955, he taught Maths and Science at Dulwich Hill Central, while at night he studied for a Bachelor of Arts degree at Sydney University for which he graduated from in February 1954. During this time (January 9, 1954), he married Pat Sharp at Five Dock Methodist Church and they lived at West Meadowbank then at Chiswick.

His teaching career continued through 1955 and 1956 at Leichhardt Junior Tech where he taught English and Social Studies, as well as leading the youth group at the church. It was during this time he was appointed General Secretary of Methodist Christian Endeavour for NSW.

From October 1955 to April 1956, Rev Dr Adams candidated for Methodist Ministry and was a Methodist Probationer in North Parramatta (Rydalmere) and at Boolaroo. During this time, he completed his Bachelor of Divinity (outside of University of Sydney).

He was ordained at the Gordon Methodist Church during Conference, October 1959. For the next 14 years, Rev Dr Adams served in many roles including South Bathurst Methodist Church, the Central Methodist Mission Sydney and Hamilton Methodist Church.


From 1974-75, he was on the Board of Mission, Chatswood and served the Waverley Methodist Mission from 1976 for 12 years including at the Church in the Market Place at Bondi Junction in November 1976.

The Uniting Church in Australia (UCA) was formed on June 22, 1977 and from 1983-87, Rev Dr Adams was Chairman of the Sydney Presbytery. He then moved to the Parramatta Parish of the Uniting Church in Australia (UCA) from October 1987 to January 1994, and during this time was also Moderator of the NSW Synod of the UCA from 1989 to 1990.

Rev Dr Adams graduated with a Doctor of Ministry from the San Francisco Theological Seminary in 1990. With a move to Queensland in 1994, he served with Wesley Mission Brisbane, Albert St Church, for six years.

Retiring in 2000 in Brisbane, Rev Dr Adams moved into his own home with Pat for the first time. He and Pat had 4 children, 11 grandchildren and 5 great grandchildren. Bill loved wider life including sport, music and the outdoors. Bill and Pat loved to travel. Rev Dr Adams was grateful to minister in many different settings NSW and Queensland also including places around the world. He had the honour and the challenge of leading his church in a difficult time, but he found more support and encouragement than he ever imagined. He always sought to reach out to people in the community as well. Rev Dr Adams continued well after retirement, leading weekly services at his retirement village and in the nursing home where Pat had been a resident and died in 2020. He passed away on June 30, 2024.





Rev Robert (Bert) Adrain

Bert Adrain was born on December 3, 1936 and arrived in Brisbane in 1950 from Belfast, Northern Ireland, with his parents, twin brother and four sisters. After attending Holland Park Primary School, Bert was employed at Chandlers Electrical Store, and then at MacRobertson's Chocolates, where he trained as a window dresser. His home congregation was Zillmere Methodist Church.

Bert was called up for National Service in 1955 and served two years with the Citizens Military Forces. He was also involved in the Methodist camping movement under the leadership of the late Rev Ivan Alcorn. It was during this period of his life that Bert experienced the call of God to ministry and struggled with this challenge for many months. Then God spoke to him in

an unexpected and wonderful way – a vision in which Christ said to him, "You have been saying no to Ivan, but you can't say no to me." Bert said "Yes" to God and began to prepare himself for ministry by attending evening classes.

He was accepted for training as a home missionary in 1957 at the Methodist Home Mission Training College and was then appointed to the Biloela and Mitchell Home Mission Stations. During this time, Bert undertook further studies and candidated for the Methodist ministry in 1960, entering Kings Theological College for three years of study.

In January 1964, Bert was appointed to the Allora Clifton Methodist Circuit for two years, and in April he married Judith at the West End Methodist Church. While he was at Allora, Bert fulfilled his final studies and was ordained at the Methodist Conference in 1965. In 1966, Bert was appointed to Tara and in 1971 to Toowoomba. During his period on the Downs, he worked manually to support his ministry in rural circuits.

The ten years from 1976 were spent at Ayr in the Burdekin district of North Queensland. Here he saw the transition from Methodist to Uniting Church and was active in the growth of the Blue Nursing Service.

In 1986, Bert was appointed to Burleigh Heads on the Gold Coast. While there he oversaw the development of a new building complex. Then it was back to North Queensland in June 1993, this time to Ingham for a further seven years. He was appointed Chairman of the Southern Zone of the Presbytery of North Queensland and served on the Pastoral Relations Committee.

Bert's ministry was very much a "people's ministry" with Judith his strong partner on this journey. His pastoral and practical care within a local congregation endeared him to many over the years. He retained a deep loyalty to the Church he served and is admired among his colleagues for his steadiness and faithfulness – a truly pastoral minister.

Bert and Judith retired to Oxenford where Bert continued his ministry as part-time supply for several years starting at Labrador then Coolangatta, Paradise Point, Burleigh Heads, Blue Care at Woodlands and finally at Nerang. When Nerang, Coomera and Pimpama became the combined congregation of Living Rivers, Bert together with Rev Reg Skippen regularly preached to support the three churches and provided voluntary pastoral care.

When Rev Colin Batt arrived at Nerang, Bert along with Judith continued to be active in supporting Nerang Uniting Church as their home church.

At the age of 87, Rev Adrain passed away on February 7, 2024.





Rev Kevin Frederick Bachler

Kevin was born in Brisbane in October 1941, the only son of Frederick and Edna Bachler. Initially, the family settled in Morningside on Brisbane's south side and in 1951 they decided to give up the "old Queenslander" and move to a more compact home at Cannon Hill which was closer to his father's work at the Brisbane Abattoir. Kevin's early education took place at the Morningside and Cannon Hill Primary Schools. He attended The Brisbane State High School at West End where he completed his Senior. He took part in athletics and was a member of the Army Cadets and played the bugle in the Cadet Band.

Kevin's family was associated with the Balmoral Methodist Circuit and his early Christian formation took place first at the Morningside Church where he had been baptised and then at Cannon Hill. He has fond memories of attending Sunday School and youth activities and participating in Field Days. He was further nurtured by his membership of the Methodist Order of Knights and eventually became the leader of the group at Cannon Hill. He was also involved in District leadership of the Order.

Kevin has always been grateful for the encouragement and mentoring of ministers and lay people in the Balmoral Circuit who supported him and other young people by encouraging them to take up teaching and leadership roles. During the Leighton Ford Crusade in the late 1950's Kevin had a life changing experience which prompted him to think about preaching and further work in the Church. With the encouragement of Rev Roy Klein, he and some of his friends formed a "Preaching Band". Kevin began studying at the Methodist Training College at Kangaroo Point and became an accredited Lay Preacher in 1961. For a couple of years, with the encouragement of ministers and lay people, Kevin was challenged to consider the Ordained Ministry. After some struggles the call became clear and he candidated in 1963 and was accepted by the Methodist Conference to train for the Ordained Ministry.

Kevin left his work in the Queensland Education Department at the end of 1963 and to his great surprise the Conference, "in its wisdom", sent him as a Probationer to the North Rockhampton Circuit where he lived in the back of the Berserker St Church for 12 months. As this was Kevin's first time living out of Brisbane it was a huge learning curve for him. Fortunately, he had significant mentors like Rev Neville Ross and his family, the Rev Aubrey Baker together with the support of many lay people. Together they made the year a very special one of challenge, learning and growth that stood Kevin in good stead for future training and ministry.

Kevin continued his preparation at the Methodist Theological Hall at King's College within the University of Queensland from 1965 to 1969. These were not easy years to be training given all the change, flux and uncertainty happening in the Church across the world. Only three of the fifteen candidates in Kevin's year completed their training. Under the influence of many significant teachers Kevin was challenged to rethink his idea of ministry, to be open to change and to ponder upon what ministry might be like in the future given the church would probably dramatically change in his lifetime. Along with his Theological formation, Kevin began working on a BA and BEdSt degrees fulfilling his interest in education and teaching. A helpful part of his training was being allowed to work in practical situations during the long vacations. He worked for three months in each of the Coolangatta and Holland Park Circuits and at Lifeline Brisbane. Kevin also did Student Placements in the Annerley Circuit (1968) and Indooroopilly Circuit (1969). In 1968, while Kevin was still in college, his father died suddenly at work at the age of 61. This was a great blow to him and his mother and presented them with many challenges both at that time and later on. Kevin continued studying after leaving college and eventually obtained a BA (1977), BEdSt (1984), and a MEdSt (1990). He is a member of the Australian College of Educators and a Registered Teacher.

Kevin was Ordained by the Queensland Methodist Conference in October 1969 and was stationed in the Brisbane Valley Circuit. From 1977 he served the Uniting Church in the following Placements: Central Burnett,



Hervey Bay, The ScotsPGC College (Warwick) as Chaplain/Teacher, Gympie (supply), Stephens Yeronga, and The Wesley Hospital as Chaplain-Educator. In this role Kevin lectured in and facilitated the Ecumenical Hospital Ministry and Pastoral Care Course which came under the umbrella of Trinity Theological College. He stayed at the Wesley until retirement in 1977. Kevin's ministry has been a varied one covering country and city parishes and special situations. All provided him with opportunities and challenges for ministry.

The pastoral care Kevin offered in all the congregations in which he served was very much appreciated His preaching was always challenging and sometimes controversial. He was always well prepared and challenged people to be open to new ideas and to rethink their Christian faith and service in the world.

In 2008, Kevin and Hazel moved into their home at Golden Beach and became involved with the Caloundra Uniting Church. Kevin was a pastoral leader with Hazel and served on various committees and church council. He loved going to the Men's Breakfasts, active over fifties (now called joy – Just Older Youth), Mainly Music, Messy Church, Explorers Group.

Kevin also took up supply ministry at various places around the Sunshine Coast and remained part of the Synod Chaplaincy Commission and the Multi-Faith Health Care Council, which he had been a member of since their inception. All of this proved to be challenging and kept the mind active. Kevin also took on some "JPs in the Community" work at the Caloundra Court House and Caloundra Library which he concluded in 2002.

Throughout his ministry since 1977, Kevin was ably supported by his wife Hazel (nee Hooper). Into their partnership in ministry, she brought talents in music; youth leadership – having been the State Superintendent of the Methodist Girls Comradeship in Queensland; and ministry with adults. She has worked closely with local Adult Fellowships, Presbytery Adult Fellowship Committees and has been a member of the Queensland Synod Committee for Adult Fellowships for a number of years having served three terms as its Treasurer.

One of her great loves was teaching Religious Education in schools which started when they were in Hervey Bay and continued at The ScotsPGC College in Warwick. For a number of years Hazel taught RE to Year Four's at Yeronga Primary School where her teaching and class management was appreciated by teachers and students.

Hazel's secretarial skills were also much appreciated and put to work in many situations. Prior to Kevin's retirement and their move to the Sunshine Coast, Hazel worked tirelessly for many years as the Office Secretary for the Yeronga Congregation. Wherever Kevin ministered Hazel's contribution, openness and friendliness were evidenced and appreciated.

Rev Gordon Burley

The Church is a changing and evolving animal that, at times, seeks new and innovative ways in which to proclaim the Gospel of Christ to an increasingly diverse and skeptical society. But, often these take off like a sky-rocket and then quickly fall away, to be replaced by the next and best.

But, there are certain individuals in the church who, through tenacity and prayer, find ways that do engage society and are able to speak into the longing of the world. Gordon has been such a person. His quiet demeanor and friendly smile covers a man who with wisdom and giftedness has used the technologies of the age to proclaim the message of the church, not with flash and drama, but with a gentleness that, in itself, mirrors the still small voice that God longs all the hear and to respond to.

From the 'Shepherd of the Outback' to voice over's and radio spots, Gordon has brought a plethora of insight and wisdom into the field of communicating God's central message. Gordon has also demonstrated his Godgiven gift to communicate across not just distance, but racial and cultural divides as well. His experiences in overseas locations and, in particular, Papua New Guinea, have served him well as he has ministered to people of differing back-grounds by speaking the Gospel in a way that cuts through any human divides.

But, Gordon has been more than a skilled communicator. He has also been a gentle pastor and teacher. His laid-back style and easy manner have inspired people to also become preachers and teachers within the many placements that Gordon has undertaken in this Presbytery. He has demonstrated what a true gentle spirit can do when faced with the difficulties of life and the complexity of Church. His words are rarely spoken without deep reflection and are therefore often words of wise counsel.

Gordon has also been an inspiration to ministers and lay leaders in this Presbytery as well. He has walked beside, guided and encouraged a great number of people, not to be like him, but to hear God's call and to be the people God would want them to be. I am sure that, despite his failing health and subsequent retirement, Gordon, faithfully aided by Ainesa, will continue to inspire and guide many people in the years to come.

Rev Dr Michelle Cook

Rev Dr Michelle Cook was a beloved and highly respected minister in the Uniting Church in Australia, known for her deep faith, wisdom, and passionate commitment to justice and discipleship. Her early Christian formation took place at Indooroopilly Uniting Church in Queensland, where she was nurtured in faith and encouraged to explore her call to ministry.

Michelle's ministry took her to a range of diverse communities. She faithfully served in Weipa, the Frontier Services' Cape York Patrol, Mapoon, Yalga Binbi, the Presbytery of Tasmania, and Nungalinya College.

In April 2024, her dedication and leadership were recognised when she was elected as the Moderator-elect of the Northern Synod. Her untimely passing before she could take up this role is a profound loss to the Church and to all who valued her wisdom and vision. Throughout her ministry, she embodied the diaconal calling—serving those on the margins and putting the gospel into action in ways that were both practical and transformative.

Michelle's theological insight and leadership extended to the national level of the Uniting Church. She was a member of six Assemblies and served two terms on the Assembly Standing Committee. She contributed significantly to the development of Uniting in Worship 2 as part of the Working Group on Worship and convened the Assembly's Task Group on the practical outcomes of affirming First Peoples' sovereignty. She was a tireless advocate for the Uniting Aboriginal and Islander Christian Congress and a passionate supporter of the Church's Covenant with First Nations peoples.

Her commitment to justice and reconciliation was reflected in her academic research. She was awarded a PhD in Practical Theology for her work exploring the Church's multicultural and covenanting commitments through the perspectives of young adults. She envisioned a Church deeply engaged in justice, listening, and shared learning, and she worked tirelessly to elevate the voices of others.

Michelle's life and ministry were marked by a profound integrity, good humour, and an unwavering commitment to Christ's mission. She was a mentor and friend to many, known for her wisdom, generosity, and the clarity with which she proclaimed the Gospel. Her presence enriched the communities she served, and her influence extended far beyond her official roles.

Michelle passed away on 2 November 2024 following a tragic accident. She is deeply mourned by her family—James, Zane, and Marda—her parents, Russell and Cheryl, her brothers Scott, Gavin and their families, and all who loved her. The Church gives thanks for her faithful service, the love and grace she shared, and the lasting impact of her ministry.





Rev Patricia Darby

Patricia Alberta Linnette Darby was born on the 20th May 1935 to parents Albert & Adele Savage at a small cottage hospital in Kangaroo Point, Brisbane. Pat attended Kangaroo Point Primary School and State Commercial High becoming a Prefect in her graduating year. During her school years, the family attended St Mary's Anglican Church and Pat was involved in their different clubs and activities. Pat lived in family home at Kangaroo Point until she married Wellsley Thomas Darby (*Jack*) at St Mary's on the 12th February 1955.

After completing school, Pat worked in the economics department at the University of Queensland, and it was through square dancing socials that she met Jack. Pat and Jack had 3 boys: Ian, Keith & Craig. From 1968 – 1970 the family lived on Palm Island, moving there for Jack's work. After Palm Island a position opened up with the Darling Downs Regional Education office so the family moved to Toowoomba primarily for Ian to attend High School. In

1973, Patricia and Jack were asked if they would run the Tufnell Children's Home in Nundah – a position they held until the home closed some five years later.

While Jack remained with the Education Department until his retirement in 1993, Patricia worked under Rev Cecil Schloss (and others) in the Church's Division of Child and Family Welfare as co-ordinator of the woman's shelter and half-way homes. It was during this time that Pat felt called to ministry and undertook a Bachelor of Arts and Theology degree at University of Queensland and Trinity College Auchenflower. Patricia was ordained in 1992 at Albert Street Uniting Church and in 1993 became the minister at Toowoomba City Church followed by Wesley Uniting Church, Toowoomba. After Wesley Uniting closed, Pat moved to Middle Ridge Uniting and led worship there for five and a half years until her retirement in 2001.

Pat also served the church at Presbytery and Synod levels while faithfully leading the people of her parish. Outside of congregational commitments, Pat also worked as a Chaplain at the Westbrook Correctional Centre for Youth — their first female Chaplain. Pat was also involved in ecumenical activities, something that gave her great encouragement and hope. Jack was a constant support and assistant for Pat during her ministry years and together they enjoyed many trips overseas in their retirement years.

Pat felt ministry was both challenging and special. It enabled a freedom of vision and movement that gave added dimension to God's gift of faith being lived out. She said that, "the Uniting Church from its Christ-centredness, [was] filled with an openness to listen, to hear and to act upon what the winds of change may be saying [but] recognised the richness of traditions and the hope that lies before it as part of God's whole church".





Rev Lynnette Margaret Falkenhagen

During the service for her ordination in 2013, Lynnette shared the story of God's call upon her life to be a minister. The call came when she was a young woman and stayed with her over the years.

She had been involved in many things in the years between the initial call and her ordination as Minister of the Word.

At Presbytery meetings and during retreats, Lynnette would share her love of Guernsey cattle. She would become upset if we accidentally said Jersey cattle. Yet it was in talking with her that the care and enthusiasm that was evident in her love of dairy cattle was in some way the care that

she held for God's people. At times Lynnette was heard to say, "I hope that the people know that their pastor loves them."

Lynnette's years on the dairy farm gave her an appreciation of issues facing rural people and of the people themselves. She has an understanding of the pressures and long hours that people worked. This helped her relate to the sugar cane farmers of Sarina.

Lynnette particularly enjoyed the pastoral visitation aspect of her ministry. Pastoral care was given across the age groups. She shared stories about talking with young people and families as she prepared children for baptism. She visited clients in her role as BlueCare chaplain.

Lynnette began ministry in Sarina, when she was commissioned as a Lay Pastor on the 17th March 2006. The Uniting Church, had a scheme whereby a pastor could undertake a course of study which would lead to a transition to Minister of the Word. Lynnette proudly announced to the moderator, Rev Kaye Ronalds, in early 2013 that she had completed the requirements. The Presbytery began the process for her ordination.

In 2015, Lynnette was inducted into the Tannum Sands congregation. This was a joint placement with BlueCare. Wider work within the Presbytery of Central Queensland saw Lynnette participate within the Joint Nominating Committee for the Iona West congregation, in Mackay, as they undertook the process of discerning God's will for them in seeking and calling a minister. Lynnette faithfully involved herself in the process which went for a longer period of time than expected.

Lynnette involved herself in the Presbytery meetings and in the ministers' retreats.

Lynnette has been a dedicated team member on many Emmaus Walks as an assistant spiritual director and in other team roles. Lynnette's pastoral care skills were evident in her daily activities.

She was energetic when she spoke of reading the bible to and praying with residents at the Blue Care facilities and she took great joy in singing with them and to them.

Over the years, Lynnette had shown her love of God. She has shown her response to the call of God on her life despite the long time until the call eventuated.

Rev George (Len) Forrest

Len (with his twin sister Dawn) was born on September 25, 1937 and along with his brother and sisters was raised during the difficult days of World War II. His brother was tragically killed in a motorcycle accident at age 21 and this was a pivotal point in Len's life when, at the age of 15 he responded to the call of Christ at a Bellevue Youth Camp, at the New Years Eve 1952 Watchnight Service led by the late Rev Ivan Alcorn, and conducted in the then Southport Methodist Church.

He completed his studies for candidature for the Ministry and was accepted by the Methodist Conference in 1956 – at that time the youngest candidate ever received.

His year of probation was in the North Queensland town of Mossman which gave Len the thrill of "preaching the Word" and ministering with the people there. During this time, he signed the contract for the building of a new Methodist Church in Mossman.

Following this year, he entered Kings College to complete his four years study with the Methodist Theological Hall within the University of Queensland, providing him with great years of learning and preparation.

He married his long time sweetheart Betty at the Torwood Methodist Church in December 1960 and those who have met and known Betty as they have moved around the State, experienced her many talents and tireless contribution to the life and witness of the church.

During Len's appointment to the Cloncurry Circuit, with a first time experience with people of different cultures, their daughter Jennifer was born.

Len was ordained at the Albert Street Methodist Church in 1962 following which he was appointed to Longreach and Mackay. It was during this time that their two other children – Glenn and Judith were born. During Len's appointment at Mackay he shared ministry with Rev Rowley Barnes and became Associate Director for Blue Nursing Service, beginning a long association with Blue Nursing which extended throughout his whole ministry.

As a senior minister Len was called to Beenleigh, Cairns and St David's Coopers Plains. In the Surfers Paradise Parish he shared in a major re-development including the sale of the Clifford Street property, purchase of land at Robina, as well as guiding and giving spiritual support to the relocation of four congregations to become "One People in One Place with One Purpose in One Power" on the new Robina site.

In each of these places Len served in many capacities beyond Parish Minister including Director of Blue Nursing, Industrial Chaplain, Chair of Methodist Hospital Chaplaincy Commission, LifeLine Board of Management, Chair of Northern Zone Presbytery, Presbytery Pastoral Relations, and many other Boards and Committees.

In the last six years of ministry, Len served as the Blue Care Chaplain to the Southport/Surfers Paradise Centre. His compassion, pastoral care and counselling was appreciated by all who came in contact with him in this role at Blue Care.

After his retirement in 2003, Len and Betty bought a home in Parkinson on Brisbane southside and returned as congregation members at St Davids Uniting Church, Coopers Plains, where they continued to worship for the remainder of his life. He enjoyed being part of the Mens Maintenance group and ensuring the appropriate banners were hung in church for worship each Sunday.



In these retirement years, Len and Betty enjoyed travel in Australia and overseas but their most treasured days were spent with their children and their spouses, their beloved grandchildren and were so delighted to be able to see new great grandchildren.

In 2014, they moved into an Independent Living unit at Bethany Christian Care in Eight Mile Plains where they spent almost 10 years before challenging health issues saw Len and Betty move into Serviced Apartments then into High Care.

On the day before he died, when fading quickly and was told probably heading for Heaven, Len responded "Well I'll look forward to that".

Once reassured that his beloved Betty would be cared for, and his minister had come to pray with him, his beloved family surrounded him with prayer and love.

Rev Forrest passed August 15, 2024 at the age of 86 years.





Rev Mervyn Genrich

Mervyn Genrich was born at Crows Nest, Qld on 16 January 1930, the son of Ed and Jo Genrich, a third-generation member of a strong Methodist family. A twin sister died in infancy and Merv has a younger sister, Marlene. He grew up on a dairy and grain farm, milking cows before and after school. His schooling was at the Crows Nest and Pechey primary schools, concluding with the state scholarship at age 12. By that time, he had completed his 'apprenticeship' ploughing with Clydesdales, having been entrusted with a team of four horses at the age of 11.

In his late teens, he moved to a dairy and cane farm at Nambour, where he cut and hauled cane in the premachine days. As well, he did contract ploughing and rotary hoeing on the steep hills around Nambour.

At Nambour, Merv was nurtured in strong Chistian fellowship through the Order of Knights and Christian Endeavour, under the ministries of the Revs Ronald Howe and George Smith. A commitment at a combined crusade stirred a call – but to what? For a lack of education was a big barrier to any fulfilment of that call to something like an agricultural missionary. No doors seemed to be open.

A call to the ordained ministry came through an Overseas Mission deputationist preaching on Isaiah's call "Whom shall we send, who will go for us". This call to ministry was strongly confirmed at the first National Christian Youth Convention in Sydney in 1955. This call became Merv's continuing basis for ministry.

Merv was accepted by the Methodist Church for Home Mission training in April 1956, at the Home Missionaries Training Institution under the late Rev Donald Brumwell. He was immediately seconded to assist the late Rev A A Mills in the Darra Home Mission Station. He was thrown in at the deep end by Rev Mills. On the first Sunday, Merv found himself a Sunday School Superintendent for the first time and trebled the number of services he had ever conducted on his own. In the next week, R.E. classes of up to 70 children at the Oxley, Darra and Richlands schools were hi introduction to that area of ministry.

In October 1956, Merv was sent to supply the Maranoa Mission at Roma. For the last three months of this appointment, he was the acting Master of the Students Hostel, with responsibility for 46 young people. In 1957-58, he was home missionary at Yeppoon and was accepted as a candidate for the ministry in 1958 and sent to Clermont. He came to King's College for 1959 and 1960 and although still officially in college, he supplied the patrol ministry at Cunnamulla during 1961.

In December 1961 Merv married Jean, a daughter of Bert and Amy Richards, in the Kingaroy Methodist Church. Jean came from a background deeply steeped in the things of the Faith, and of Christian service and brought her special gifts to the ministry which they would exercise together over the following years. They have three children – Noel, born in Bowen when Merv was in Brisbane for ordination: Leanne, born in Gympie and Russell in Brisbane.

Merv and Jean went to Bowen for two years, and Merv was ordained at the Conference of October 1963 in the Albert St Church. After ordination, their appointments were Imbil 1964-66, Balmoral 1967-72, Maryborough 1973-79, Pittsworth 1980-86 and Beaudesert 1986-91. In all of these appointments, Merv sought to express in his own way the call to ministry which had come years before. In the country appointments, he had a close empathy with those who made their living from the land, and in every appointment he sought to uphold his Master as the Saviour of the world.

Merv was one of four people who entered the ministry from Nambour in the space of two years. It was always a puzzle to him why several people far more talented and better equipped than he though he was, did not receive a similar call. But God had called him, he responded, and he did not regret it.



Merv retired to Caloundra in December 1991. Here he and Jean settled into the life of the Caloundra Parish. Merv continued support ministry, conducting services in neighbouring congregations and Holy Communion in local aged care facilities.

Merv and Jean were also able to return, 20 years later, to Balmoral Parish for a period of supply ministry.

A passion that developed from his farming roots was the cultivation of orchids. They joined the local orchid society and served in various committee positions. Merv was awarded life membership.

After a short illness, Jean passed away in 2008 which left a large hole in Merv's life. Merv remained in the house in Caloundra for another decade with regular community and family support. Failing eyesight and mobility led him to move to Brisbane to be closer to family for easier regular support. Merv settled into The Plains retirement village at Eight Mile Plains.


Merv joined the St David's Coopers Plains congregation and enjoyed the online services that began with the COVID-19 pandemic.

With advancing age and increasing health concerns Merv moved to residential aged care. At the end of April 2024 Merv contacted a respiratory infection that led to hospitalisation, and he passed away peacefully on 28 April.

Merv had a full life of farming, ministering to many people, family and orchid growing. In an extract from his life story, Merv said:

"Now, as I put together the patchwork of my life experience, looking at it from the detached viewpoint of hindsight, the outstanding constant factor is the ever-present grace of God at work."





Rev Cecil Geyer

Reverend Cecil Lawrence Geyer was born to Cecil and Violette Geyer of Tenterfield, New South Wales on 22nd February 1937, the youngest of 5 siblings. Cecil's father died, tragically, just three weeks before he was born so while he never knew his father, he was given his name in his memory.

The family moved to Wavell Heights, Brisbane in 1944 and he quickly became immersed in all kinds of sports: cricket, squash, tennis, table tennis, and golf. He was by all accounts a very accomplished and talented sportsman.

Cecil's love for God was learnt from his mother Violette and the whole family were fully involved in church life both in Tenterfield and in Brisbane. Church was a central part of his life and it was at a church social that he met his wife of 63 years, Noelene. They officially became

an item just before her 17th birthday and were married on the 28th January 1961.

Cecil and Noelene had four daughters: Tania, Karmel, Colleen, and Narelle. Family was precious to Cecil and he delighted in his children and grandchildren.

Prior to becoming a minister, Cecil served with the Citizens Military Force as part of his national service and also worked for eighteen years in the insurance industry both in Brisbane and in Hobart, Tasmania.

Always central to his heart was sharing God's Word and at nineteen he received his Local Preacher's Certificate. The call to ministry came and Cecil followed diligently, attending Theology at Kings College Queensland in 1976 and obtaining his Divinity Degree in 1979 from the University of Queensland. Rev Cecil Geyer was ordained on the 24th May 1977 and served in the following parishes:


1997 – 2001 Glamorgan Parish, Tasmania (VicTas Synod) Retired August 2001

This list doesn't include the many other congregations and services he took during his ministry, nor does it do justice to the lives Cecil touched over the years. He was said to be a scallywag and a story teller who had a knack for being comfortable talking and sharing the gospel with anyone he met – whether someone he knew well or not at all, you would be greeted with a smile.

Though Cecil's final years were tough, he was surrounded by the love of family and dear friends who journeyed this time with him. Cecil passed away on Friday 5th July 2024 and his funeral service was held at St Paul's Stafford Uniting Church on Tuesday 16th July 2024.

As an excerpt from his Eulogy, Cecil once wrote to the Tasmanian Synod the following words: *However, nothing comes close to my Lord who has allowed me to enjoy such beautiful experiences, and through all of this I have come to understand what He meant by "I have come that they might have life in all its fullness"*.





Rev Alaric (Gale) Hall

Rev Alaric *Gale* Hall was born during World War II on the 21st November 1941 in Kilcoy, Queensland to William Alaric and Ellen Hall nee Carseldine. His father was away serving in Syria, so his birth made the newspapers as he was the first baby born to a soldier from the district. Gale spent his early years in Kilcoy with his siblings, Ellen, Neil, Noela and Heather. After the war, the family moved around several places in South-East Queensland before settling in Chermside, Brisbane.

Gale and his family were key members of the Chermside Methodist Church and as a young man, Gale was heavily involved in the Sunday School, Methodist Youth, Methodist camping ministry and athletics.

Gale was a key leader in the Secondary School camps, held at Southport on the Gold Coast during the 1960s. Gale attended five different primary schools and was a founding student at Kedron High School. He went on to study at Kelvin Grove Teachers' College and the University of Queensland teaching in both primary and secondary schools before answering the call to ministry. Gale also earned a Master of Education degree while in Townsville.

Gale served his Probationary year at Wynnum Methodist Church in 1965. From 1966-1969 Gale undertook a Bachelor of Divinity as a student at King's College, University of Queensland and was ordained in 1969. Gale celebrated his 50 years of Ordination in 2019 along with colleagues Bob, Noel, and Kevin at the Albany Creek UC where he was an active member supporting and mentoring others.

In 1968, Gale married Phyllis and after his Ordination they moved to Mackay, where children Liesl and Robert were born. In 1973, the Hall family moved to Papua New Guinea where Gale served as the Chaplain and lecturer at Gaulim Teachers College, near Rabaul. Gale's down to earth approach and personal interest was greatly appreciated by the students.

Upon returning to Australia in 1976, Gale served in the congregation of Aitkenvale, North Queensland and from 1982 in the Woodridge/Kingston parish, Logan City. During his time in Aitkenvale Gale chaired the Lifeline Board, led the congregation through Union and walked alongside the people of Aurukun during a conflict with the government over mining rights.

Gale held several significant Synod positions such as CEO of UCA's Child & Family Welfare Department from 1985 – 1993 and General Secretary for UCA Northern Synod in Darwin from 1993 to 2000. Gale will be remembered as having a strong pastoral ministry. In particular, it was his strategic thinking and strong support that was valued greatly by ministers and leaders across the Northern Synod, especially to the Uniting Aboriginal and Islander Christian Congress. In the last placement before his retirement, Gale served as Director of Mission and Co-ordinating Chaplain of Blue Care. This position he pioneered and developed, itself being a major contribution to the work of that organisation.

From 1976 to 2001 Gale served as a part-time reserve chaplain with of the Defence Force Corps, one of only a handful to work across all three services: Army, Navy and Airforce. Gale's leadership skills were recognised by the Military and before retirement Gale served as Senior Chaplain and Staff Chaplain. For twelve years he was involved in pastoral care of Chaplains (full-time and part-time) and their families, recruitment and endorsement of Uniting Church Chaplains and Governance. He was Chairperson of the Defence Force Committee and was the UCA Representative on the Religious Advisory Committee to the Services.

Gale's Retirement Minute for the 26th Synod in 2007 reflected on his active ministry, his compassion for people, his no-nonsense approach and his dedication, loyalty, hard work devoted to his calling. In retirement, Gale was busy. He was the support minister for the Lay Ministry team and routinely preached on the roster at Kilcoy



Uniting, the church of his childhood. He also accepted supply placements at The Gap and Chermside Kedron Congregations and was on numerous organisations' boards and advisory committees. Gale continued his Defence Force work after retirement through his work as Padre to the Bray Park-Strathpine RSL and he was very active in Friendship Force International and his Probus club. He also volunteered routinely at the tuckshops at his grandsons' schools. In these ways he continued to minister to those inside and outside the church.

He passed away on Friday 3rd November 2023 just 18 days shy of his 82nd birthday. His Celebration and Remembrance Service was held at Chermside Kedron Community Church on the 14th November 2023. He will be remembered as a caring and compassionate leader. His wisdom and understanding of what it meant to be called by God underpinned his ministry practice and his thoughtful consideration impacted many.





Rev Beverley Ham

Reverend Beverley Ham died on the January 18, 2024

Beverley ['Bev'] Ham grew up with the Methodist church in Gympie. In 1960 Beverley trained as a Deaconess, two years later was ordained as a Minister. In 1971 with the United Church in Papua New Guinea Bev was a high school chaplain. In PNG Bev recorded that "understanding the world mission is about appreciating thinking about developing countries, their needs and the role of the church in the community".

Back in Australia Bev had various postings as a church minister and council chair in Beaudesert, and then in a mining community in Greenvale. "A hard hat posting!", Bev recalled. Bev helped to establish Lifeline's first telephone crisis counselling service at Ipswich in 1973, training counsellors. In the 1980s Bev's ministerial work included postings in Laidley, Biloela. In 1994 Bev worked in

Longreach for 5 years. There she supported the running of the church parish and the rural and remote families located away from the town on cattle stations helping them as much as she could with so much energy.

Bev's career highlights include attendance as a delegate and speaker at world conferences; including Solomon Islands; Women's World Methodist Conference' in Nairobi, Kenya; Philippines; Derbyshire, England; United States.

In 2000 Beverley retired from full time ministry. In semi-retirement Bev had supply posts in Alice Springs, Northern Territory; Broome, Western Australia; Norfolk Island; Tocumwal, New South Wales; Port Macquarie, New South Wales. In 2010 – 2017, at 70 years of age Bev became a Cruise Chaplain with Holland America Cruise Ships working on cruise tours in Vancouver, Hawaii, Hong Kong and Southeast Asia, Sydney, Alaska. Appointments on 14 different cruises included thinking in ecumenical relationships with Bev conducting Sunday church worship, bible study groups, conducting an Anzac Day Service, while on a cruise in Australia. Ministerial duties in retirement Bev conducted services and was often called upon right up until 2022. With a Chronology of Beverley Ham's ministry years and career highlights, you could say that she was a trailblazer in her working life and in her retirement from full time ministry.

Chronology of Beverley Ham's ministry years, career highlights and experiences.

Bev had a reputation of being a trailblazer and troubleshooter. A woman ahead of her time. In Bev's 36year ministry she was also sent to trouble spots, including Papua New Guinea.

1960-1963 trained as a Deaconess in the Methodist Church.

1966 After a two-year probation, various appointments in circuits, Bev was ordained.

1971 World Mission. High School Chaplain with the United Church in Rabaul, PNG. Developed understanding of the World Mission, Bev said "is about appreciating thinking about developing countries, their needs, and the role of the church in the community".

1972 - 1974 Uniting Church Minister at Beaudesert, QLD

1973 Support for training of counsellors for establishing Lifeline crisis phone counselling in Ipswich, QLD.

1974 Mining Chaplain at Greenvale near Townsville Bev was 34 years old. A hard hat posting, Bev was asked to go to an experimental ministry, combining churches denominations to begin an ecumenical venture.

Synod involvement, Kawana, Sunshine Coast, QLD for 6 years



1976 West Moreton Presbytery, QLD one year as Secretary (when no one would take it on!) 1977 Delegate to the Inauguration of the Uniting Church, Ipswich, QLD.

1978 Student at Trinity Theological College, Auchenflower, QLD. 1979 Ordained as Minister of Word, Ipswich, QLD.

1980 - 1984 Minister at Laidley Uniting Church, QLD

1981 Delegate World Federation of Methodist Women at Honolulu, Hawaii. 1982 Minister at Laidley Uniting Church parish, QLD

1984 – 1988 Minister at Biloela Uniting Church parish, QLD; Boy Scouts Australia, Biloela Group Chaplain.

1986 Conducted worship and holy communion at the World Methodist Conference in Nairobi, Kenya 1987 Speaker a Women's conference Solomon Islands

1988 – 1992 Minister at Kawana Uniting Church parish, during this time Bev helped to Establish 'Beechwood' nursing home, independent units.

1992 Speaker at World Methodist conference; evangelism and the local church, Derbyshire, England 1994 – 2000 Uniting Church Parish Minister, Longreach

1995 Police Chaplain Longreach, Bev was 56.

1997 asked to preach at a funeral in Philippines.

1999 Pittsworth/Millmerran Parishes for 18 months it was a very tough and Bev was alone of support and the high expectations to resolve a 'Conflict Initiative Program'.

2000 retirement from full-time ministry.

2001 – 2006 Hostess with Cross Country Tours.

2007 – 2009 short parish supply posts in semi-retirement in Alice Springs, NT; Broome, Western Australia; Tocumwal, NSW; Port Macquarie, SW, and Norfolk Island.

2010 – 2017 at 70 years Bev became a Cruise Chaplain with Holland America Cruise Ships. Appointments on cruises including Vancouver, Hawaii, Hong Kong, Japan, Sydney, Alaska. Bev conducted church services, Anzac Day Service, bible study groups - thinking in ecumenical relationships.

2018-2022 called upon to conduct ministerial duties in retirement, Glasshouse Mountains, QLD.





Rev John Hooper

Rev John Hooper was Ordained on October 17, 1960, and served as a Minister in both the Methodist and the Uniting Church traditions.


He faithfully ministered in congregations at Ashgrove, Caloundra, Suva, Fiji, Lautoka and Mackay. He also served as the Secretary for Methodist Overseas Missions.

Rev Hooper was the Director of the Division of World Mission and was also part of the Mission and Ministry at West End.

Words fail to fully recognise the global impact Rev Hooper has had on the lives he has touched through his life and ministry, as a faithful witness and servant as a minister of Christ's Gospel.

Rev Hooper passed away July 23, 2024.





Rev Douglas Allan Jones

Doug was born at Lenswood, a community in the Adelaide Hills of South Australia on March 9th, 1929. He was the third in a family of four. His early religious life was moulded in the local Methodist church.

As a teenager he felt the call of God to become a preacher and enter full time ministry of some kind. His struggle against this call of God took some time and involved him in some life changing experiences.

He eventually submitted to that call and put it to the test by becoming a Home Missionary at the age of 21. After one year he returned to college and candidated for the ministry. After training, and marriage to Rita Young, from Yongala, they were sent to Kalangadoo in the Southeast of South Australia.

As was common in the Methodist system there were a number of placements in both rural and city churches. Of the 9 parishes in which he served in South Australia 7 of them he was able to restore to becoming viable. While in parish ministry (Semaphore Circuit) he was also the state chaplain for immigration and also an industrial chaplain at ICI Adelaide.

For two years he resigned from active ministry to recover from a breakdown from overwork. On recovery he was sent to Tumby Bay.

In 1973 while at Port Pirie he became the Chairman of the Methodist District and then the Frome Presbytery of the Uniting Church, which he fulfilled for five years, as well as being the chairman of a parish with three ministers and nine churches.

In 1982 he, and Rita, noticed an advert in the church paper for a Presbytery officer for North Queensland. He applied and was accepted. He held this position for over nine years during which time he was able to assist with the formation of the Calvary Presbytery, the opening of new areas of ministry, and bringing stability to the financial position in the area.

Feeling a need for a rest from that position he accepted an invitation to become the minister of the International Church in Tripoli, Libya. That was to be for five years, but for various reasons only lasted for two years, when he returned to Brisbane and was placed in the parish at Enoggera for two years.

After retirement he 'filled in' in a number of parishes as a supply minister including Norfolk Island. Doug and Rita moved to the retirement village at Allora Gardens Maroochydore in 1999.

In 2001 he lectured at the United Church theological college in Seghe, Solomon Islands for three months. He later was responsible for providing thousands of books for the college and the students there.

His interests were trying to understand what gave people meaning in life. This led to his study of other religions which included a study tour to India.

He encouraged people to take leadership positions in the church and trained numerous Lay Preachers and encouraged others to enter into a variety of full-time ministry positions.

Through the careful resources of their income, Doug and Rita were able to travel to many parts of the world to study how other people lived.

Though not an academic, his interest was in practical administration and church growth.



His preaching and teaching within the congregation tried to relate the truths of the whole bible to the situation in which we now live. He liked to examine the basis for religious belief and practice and was critical of anything that did not stand the test of careful examination.

He has written numerous articles and studies on a variety of subjects. One particular field has been his study of Islam and its effect upon life. Retirement gave him the opportunity to do research into a variety of biblical subjects which he continued until his death.

He liked to keep his eye open for people who needed help in different ways. To the surprise of many he suffered from severe introspection which had an effect on his relationship with other people as well as his family. He was always interested in wanting to do something to keep active and after retirement he was active with Greening Australia for 20 years in their projects of restoring bush land. This was partly for exercise but also his belief that we all have a duty to repay to the community what we have received from it, as well as an expression of his belief that the world in which we live is God's world and needs to be cared for.

While being an advocate of church union, and wanting to bring Christian people together, he had some serious concerns about some trends within the church. Through all that he still remained faithful to the church into which God had called him.

His wife Rita passed away in July 2021 and he is survived by his two children, David and Neralie, four granddaughters and 5 great grandchildren. He moved to Townsville in December 2022 to enjoy NQ weather and be closer to some family. Doug was keen to remain active and walked daily and enjoyed exploring the neighbourhoods where he lived. After a short illness, Doug died very peacefully in Palliative Care at The Townsville University Hospital on the 1st December 2023.

We were very thankful for the weeks we had with him in hospital and had lots of conversations about his life, many stories and lots of laughs. At one point he said he

hadn't laughed so much in a long time. He would often stop mid-sentence, wave his hand around for someone to hold while he had a little "weep" and then go back to where he left off. We often had to leave so he would stop talking.

Doug always enjoyed talking and supporting others.

If there had been a service, he would have liked the following to be sung:

The Te Deum.

This was always sung at the opening of the Methodist conference.

O for a thousand tongues to sing.

The conviction that in all life our goal is to proclaim the wonder of God's action.

Guide me thou great Redeemer.

The journey of life has always been a journey with God.

Rev Dr Noel Kentish

A remarkable origin

Adapted from the tribute delivered by Rev Dr Noel Kentish's daughter, Fiona Clein and with kind assistance from Mrs Coral Kentish.

Rev Dr Noel Kentish's story began in Darwin in 1935, as the son of Mrs Violet and Rev LN Kentish BA, BD [ref 'Saints of the Church'], and as a young boy, he lived on Goulburn Island, embracing a life that could only be described as a pioneer-like existence that fuelled his love of adventure, deepened his appreciation for nature, and nurtured his passion for simple living. His Father was remembered as being very kind by children from the island whom he and others assisted to escape during WWII.

Noel's early years were shaped by the love of his parents, but also by profound loss. At just seven years old, he faced a tragedy that would forever shape his story. His father was captured on 22 January 1943 by the Japanese military, who bombed the supply vessel Patricia Cam, plucked Len out of the water and carried him away in a float plane. He was executed soon after, but it was many years before his wife and family had confirmation of his death.

This loss became a defining chapter in Noel's story. One he later preserved with great care in his biographical book <u>Eagle and Lamb</u>. However, Noel's childhood was not solely marked by sorrow. It also was a testament to resilience and daring escapes.

After the bombing of Darwin in February 1942, his Father Len decided to send his wife, Violet, and their children Noel, Elaine and Claire back to South-East Queensland to the safety of Scarborough near Redcliffe. Noel would never see his father again. That moment shaped his instinct for survival and ignited his unbreakable spirit of adventure. Through it all, his remarkable Mother, Violet, held their family together, ensuring they not only endured but thrived, instilling in her children the values of resilience, problem-solving and perseverance.

Academic success and ordination

Noel overcame struggles at school during his teens: proof that academic success doesn't always come easily. Noel persisted, and in the years to come, the boy who once struggled in class worked from the age of 18 throughout the 1950s as a primary school teacher, then successfully studied at King's College. His practicum prior to ordination was completed in Blackall in 1962.

Noel was ordained as a Methodist Minister in 1963 and went on to earn a Doctorate in Education in Columbia University in New York City in the late 1970s. His adventurous spirit remained a driving force throughout his life.

1963 was the year of two highly significant sacraments - as Noel was not only ordained, but also in August that year, married his deeply devoted lifelong partner, Coral Burville, who had trained as a Deaconess. Soon afterwards, Noel served as Chairman of two districts of the Free Wesleyan Church in Tonga in a two-year mission placement. During this time, their first child, Fiona, was born, followed by their son Greg, and in 1972, Trystan completed their young family.

Service throughout the world

As a minister, Noel served continuously throughout Australia and overseas from the 1960s and in all the decades afterwards - even following retirement in 2000 - in a large number and variety of placements and supply ministry roles. Churches which benefitted from his service included Wooloowin, Clayfield, Red Hill, Charters Towers, Fisherman's Methodist Church New York, Yeppoon, Crookwell NSW, Jindalee, Kenmore, St Lucia and Indooroopilly. He was Founding Director of the Charters Towers Blue Nursing Service*. [*Blue Nursing commenced in Queensland in 1953, an enduring initiative of the Methodist Church in West End].



In New York, Noel demonstrated a quiet steadfast presence for people of all faiths, whether they were grieving a loss, celebrating a birth, or just seeking comfort, and was often their confidant. After returning to Australia from New York in 1979, Noel taught religious education at Somerville House in Brisbane [1980-1986]. In January 1987, he took up a post at Edith Cowan University in Western Australia, where he taught comparative religion to students of nursing, medicine and paramedics, as well as English and humanities. He became a Head of Department and found joy in inspiring students and challenging them to think deeply. Noel became the Principal of St Columba's College in Nedlands, WA in 1992 and of course, served the church in Western Australia in the 1990s.

But his greatest role, and the one he cherished the most was being a family man.

Of home and hearth


Through every chapter of his life, Noel had a steadfast partner by his side - Coral, her unwavering support - and her deep devotion allowed Noel to pursue his calling with confidence and purpose. She was the constant presence in a life filled with transitions. From the early years in distant postings to academic halls of Perth, Coral's dedication to Noel was boundless. She stood beside him as he followed his dreams, lifted him in moments of doubt and provided a foundation of love and stability for the family. Without Coral, Noel's journey would not have been the same. Their partnership was one of deep faith and enduring love; a testament to the power of devotion and sacrifice, in the name of family.

Noel's impact stretched far beyond his family to the classrooms, churches and communities. He served with unwavering dedication.

His daughter Fiona delivered wonderful words of affection and remembrance at his funeral at St Stephen's Uniting Church, Toowoomba on Monday 3rd March 2025. Fiona outlined that Noel lived a life of service, humility and kindness – "qualities that defined him as a husband, father, teacher, minister, lecturer and man." Fiona spoke on behalf of the family and described how the background and elements of his life defined his service to God through a life filled with adventure:

"Dad, you taught us that a life well-lived is one spent in the service of others. But also one in which we never lose our sense of wonder, you reminded us as Wordsworth wrote in The Rainbow, 'the child is father of the man'. You believe in... bringing the joy, curiosity, and simplicity of childhood into every stage of life; to see the world with fresh eyes, to marvel at its beauty; to embrace each moment with the same excitement as a child - this you showed us is the true essence of a meaningful life. We salute you, we thank you, and we will carry your legacy forward."





Rev Allan Douglas Lanham

Allan's call to serve God was often expressed through his trade within the building industry. Born on 5th November 1932 in Nambour, he went from school into the building trade from 1946 to 1953.

Called to ministry Allan spent one year at the Methodist Home Mission Training College before completing two years (1955-1957) at Maranoa Mission being based at Mitchell. The next two years were spent at Kings College Brisbane.

From 1960 to 1966 Allan moved back into the building trade. He met and married Fay Evans and they have two boys. During this time Allan was employed by the Methodist Young People's Department and built Condy Park Youth Camp at Pialha

In 1967 they moved to Mt. Morgan for five years, where once again Allan's building skills were put to good use, working to rebuild the historic Mt Morgan property and a home. The home was later sold to an Islander couple and this led to another project.

Moving to Cloncurry in 1971 Allan led a co-operative building scheme for Aboriginal and Torres Strait Islanders with government funding. This self-help project gave ownership and self-esteem to these people as they designed and paid for their own homes.

Ordained at the age of 41 years Allan accepted a call to Methodist Redland Bay Parish serving from 1974 to the end of 1976. From there he was to be called to a significant ministry of 12 years at Sunnybank in 1977 with Union. Sunnybank Parish then worshipped in the old church opposite the Runcorn State School. During Allan's time it grew from 80 worshipers to nearly 500 and moved to a purpose build complex at Hellawell Road, Sunnybank Hills. A close link with the Blue Nursing Service saw adjoining land provided for the Carramar Nursing Hostel and Independent Living Units. Allan recalls a significant ministry with Deaconess Joycelyn Bailey prior to her sudden death. Outreach ministries of Sunnybank were Acacia Ridge, and Calamvale from which grew the congregation of Living Waters (Logan West) situated at Browns Plains.

Following his divorce and a painful time of loss and grief, Allan met and later married Norma in 1987. During his ministry at Sunnybank Allan had purchased land at Jimboomba and build a home. Allan was only at Goodna for 1 1/2 years when he had to take sick leave. An overseas trip and time for healing, and Allan accepted a call to Jimboomba Parish. The time in "God's Shed" was blessed time to recall and the negotiations for the purchase and removal of the Mitchelton Church to Jimboomba for restoration and worship where part of this time.

Allan retired from ministry at the end of 1997 moving to Toowoomba with Norma and worshipped at the Rangeville Uniting Church, often preaching and working in supply roles. After a time, Allan and Norma moved to Nambour, where he continued to preach until becoming full-time carer for Norma, until her passing. Allan was living in the Nambour Estia care home, where he would preach and provide pastoral care for the residents, he always welcomed new residents and was very much loved. Allan will be missed.





Rev Jim MacLean

Our dad was formally known as Arthur James but was more commonly recognised as Rev. Jim MacLean. Dad was born in Bathurst in 1932 and was raised on the family farm at Cow Flat by his maternal grandparents.

Growing up, he attended the Cow Flat Methodist Church. His working life started as a guard on the NSW Railways, followed by time at a local produce firm. Dad commenced lay preaching at the South Bathurst Methodist Church before answering the call to fulltime ministry.

He married Joan in 1955, and they had three children- Peter, Karen and Ian.

Dad served as a Methodist and Uniting Church minister in the NSW Synod beginning in 1961 as a Home Missionary in Corrimal (near Wollongong) and then moved to Gulgong. After completing his Theological Studies in Sydney, Dad was ordained as a Methodist Minister in October 1968 at the Parramatta Methodist Church. During his studies and after his ordination, Dad also served in the following places- Tempe Park (Sydney) Ariah Park, Griffith, Kyogle, Moree and the Mortdale Parish in Sydney. During our time in Griffith and Kyogle, I learned to play the piano and organ especially to play for Dad when he travelled to many smaller country churches. Dad also led many church bus trips around the eastern states of Australia including a combined family and church tour of New Zealand in the 1981/82 Christmas holidays. He celebrated the 50th anniversary of his ordination with a special service at the Cambooya Uniting Church in 2018.

A severe car accident in 1984 brought about Dad's early retirement from full time ministry. Dad and Mum then lived for several years in the mid north coastal area of NSW and travelled throughout the state for Dad to work as a short-term relief minister. They moved to Queensland in 2002 and settled in Toowoomba, where they were involved in the St Stephen's, Middle Ridge and Cambooya congregations. Dad was also the Chaplain of the Toowoomba Scouts Association for several years. After Mum passed away in 2014, Dad continued to attend church services in Cambooya and later in Toowoomba when he needed family or friends to drive him.

Dad's longest tenure spanned ten years at the Cambooya Uniting Church where, as a retired minister, he provided pastoral care and conducted regular worship services. Throughout his ministry, Dad preached in over 140 churches and was the officiating Minister at almost 300 weddings and numerous funerals. In 1983, Dad participated in a ministry exchange program, serving as the minister at St James United Church in Watertown, Canada, for three months. Dad and Mum continued to maintain contact with their Canadian church friends for many years afterwards. Prior to their car accident, Dad was also a very accomplished singer and enjoyed participating in many church choirs and musical presentations in both NSW and Watertown. Dad finally retired from preaching and ministry when he could no longer drive himself to church.

After a few weeks of ill health in early 2024, Dad moved into the Blue Care Nursing Home in Toowoomba. He was only there for a few days prior to his passing on the 13th of March. His memorial service was held in St Stephens church in Toowoomba on March 25th, 2024.

Today, the 15th of May 2025, is a special day for us as it would have been Dad's 93rd birthday.

Rev Dr Alan Thomas Morrison

At the Synod meeting held in 1999, a minute of appreciation for Rev Dr Alan Morrison was received. That minute recorded Alan's sense of call to ministry in 1959 which was confirmed by the church, and consequently Alan was stationed as a probationer in Mackay Circuit Pioneer Valley.

In 1961 he began studies at King's College St Lucia, and during vacations ministered in Charters Towers and Nanango. Alan was appointed to Atherton Methodist Circuit in 1965 and was ordained that year. During the next five years he served in the Surfers Paradise and Brisbane Valley circuits. It was there that Alan renewed his acquaintance with Judy, and they were married in 1967.

Alan had been recognised as an excellent scholar, and in 1970, he and Judy moved to Durham in England for post graduate studies. He was awarded a Doctorate, and had the opportunity for part time lecturing,

as well as Chaplaincy at the university.

It was in England that Alan and Judy's son- Andrew- was born.


From England, it was to Papua New Guinea where he was to be the lecturer in Biblical Studies at Raronga Theological College from 1978 until 1982.

Returning to Australia, Alan was called to the Merthyr, Centenary, and Coolum parishes. In each, his wisdom and pastoral care were experienced, valued and appreciated by congregation members, and others in wider society.

Alan also served the wider church as a member of many Synod Committees and Commissions: Commission for Education and Communication; Chairman of the Presbyterian and Methodist Schools Association; Education for Ministries Committee; Chairman of Synod Schools Commission; Synod Selection Committee; part time lecturer Brisbane College of Theology; Synod Discipline Committee.

The 1999 retirement minute affirmed that Alan and Judy served the Lord and His church with diligence, loyalty and faithfulness in the wide-ranging experiences of worship, witness and service. That minute affirmed that Alan fulfilled all that had been required of him with humility, honesty, integrity- and a disturbing sense of humour.

However- all that was more than twenty-five years ago, and Alan didn't stop! He has filled supply positions at Buderim, Maryborough, Glasshouse. He was a member of the Unity College Steering Committee, and has held other positions leading studies and providing pastoral care in congregations when required- even when it came at the personal cost of his own well-being.



In 2005 he was asked to lead a seminar in the Solomon Islands. Following that, he was then asked to offer his services to Sia'atoutai Theological College in Tonga. Thus, he and Judy were to spend significant time over the



next 5 years teaching and supporting theological students and others in Tonga. During and following that time, together they also led Uniting World trips, and established connections between Unity College and Tonga.

Alan had a very rich and fruitful life - a life filled with great wisdom and compassion. He, with Judy, in word and in action, faithfully shared with others the Gospel story and the hope it holds. We give thanks for his commitment, for his wisdom, for his care- his life shared with us.





Rev Dr Marjorie Neil

RN, SCM, BHIthSc (Nursing), BTh, MA, FRCNA, RCM

Although born in Victoria, Marjorie moved with her parents to Morningside in Brisbane while still young, attending Morningside State School and later Somerville House before shifting again to Toowoomba where she completed her secondary education. Always interested in people and how best to care for them, she initially trained as a Nurse at the Toowoomba General Hospital. It was while involved in that hands on care, she felt a strong call to Deaconess training within the Presbyterian Church. Following that call, she went back to Melbourne and became an accredited Deaconess while simultaneously continuing her nursing prowess being trained specifically as a midwife.

Her love and passion for nursing was married to her calling as a Deaconess in accepting an appointment to the Paton Memorial Hospital

Vila in the New Hebrides (now Vanuatu) as a nurse/deaconess in 1957 by the Australian Presbyterian Board of Missions. Five years later she moved to Korea where she met the love of her life, Rev Des Neil, who himself was serving as a missionary. Their five children were born there. Marjorie was for five years the Executive Secretary of the Royal Asiatic Society (Korea Branch) which enabled her to share her knowledge and love of Korea and its customs with foreigners who were on appointment to Korea. She with her five very young children moved to the UK in the early seventies to support Des in his further studies and while there, apart from being a devoted Mum, worked for the National Health Service at the Selly Oak Hospital as a midwife.

She returned to Australia in 1981 and commenced work as a nurse and midwife at the Mater Mothers' Hospital, while completing her degree in Health Science. In 1993 Marjorie decided to go back to full time ministry and was ordained as a MOW in that year. She served the Uniting Church along with her husband in the parishes of Maranoa and then in Central Downs (Pittsworth and Millmerran).

Marjorie was a lifelong learner, and became a passionate advocate for ethics in both the Health and Ministry sectors. Her MA was from the Australian Catholic University where she examined The Caring Ethic of Nursing within the Bioethical Framework presently used in Ethical Decision Making - a Grounded Theory Approach. Her subsequent PhD thesis was "Mapping the Ethical Journey of Experienced Nurses now practicing in rural and remote hospitals".

Notwithstanding her health journey, she will be remembered for her service over several years in a plethora of different committees and boards where her expertise as an Ethical thinker was greatly appreciated. She served as Chairperson of the Uniting Care Health Human Research Ethics Committee, a member of the Queensland Health Research Ethics Committee and the Synod Bioethics Committee, a member of St Andrew's War Memorial Hospital Board of Governors (1988 to 1997); St Andrews' Hospital Toowoomba, Board of Governors (1999 to 2003); Emmanuel College Council, (1995 to 2007); Queensland Health Ethics Advisory Committee (1995 to 2005); Convenor of Advisers for the Uniting Church in Queensland Sexual Misconduct Complaints Committee; and the Commission for Education and Communication for the Uniting Church in Queensland, retiring officially in 2012.

Marjorie was also an Associate of the Sisters of Mercy and a member of the Mater Nursing and Midwifery Alumni.

Marjorie's years of service were not always easy and there were certainly significant challenges along the way. Nevertheless, she always took her ministry role seriously and gave of herself wholly and with great humility and a sense of God's presence and equipping to all she did. She spent her last days at the St Vincent Nursing Home at Corinda where she attended the monthly Uniting Church service often with a big smile and a 'thank-you' at the end.

Rev Dr Noel Roy Park OAM, BA, BEd St, MEd, MA Dip RE, JP

Noel was born in Brisbane and began work, following the completion of Junior Standard of Education, at the Goodna Mental Hospital. Throughout the formative years of his life, Noel was confronted with the plight of intellectually disabled people, many of whom today would not be in institutional care. This experience led to a burning drive to work for social justice. Noel was married Lyn Carter in Toowoomba at the Neil Street Methodist Church.

Noel and Lyn raised a family of 3 children, Debbie, Graeme, and lan. They now rejoice in the presence of 7 grandchildren. Throughout the years of ministry, Noel and Lyn and their family have served the church in parish settlements as well as in ecumenical settings. Despite the variety of ministry challenges that have been faced, Noel has always been able to express his desire for social justice. In addition to being a Parish Minister Noel has also served as an Industrial Chaplain, Chaplain to a Psychiatric Hospital, Tertiary Lecturer in Psychology, Honorary Probation Officer and with the Victorian State Department of Social Welfare as Deputy Regional Director in Gippsland.

It was while Noel was working with the Victorian State Government, that he began working on and preparing a program that helped lead to the re-uniting of Aboriginal families. Many of the people who were re-united under this program were children who were a part of what we now know as "The Stolen Generation". An extension of this work was made possible when Noel began work with Lifeline Darling Downs and South West Queensland. It was from this placement that Noel retired and it was also the place where he offered 20 years of strong leadership which at times placed him in conflict with Governments and the church.

Noel's passion for social justice was broadened to include work with the needs of abused women and children, those marginalised by society, the lonely and the grieving, and rural families and their needs. During the 20 years of service with Lifeline, Noel gave 15 years of intensive work for and with rural people. This work was recognised as being significant and he was awarded with an OAM, a Rotary International Scholarship and nomination as an Australian of the Year. Noel not only gave himself to Lifeline but also busied himself in serving the Church through Congregational, Presbytery and Synod activities.

On many occasions Noel acted as Chairperson of the Presbytery of The Downs while continuing to work untiringly for Lifeline. Noel applied himself to improving his education and to his great credit, all his tertiary study was done as a mature aged student using part time and distance forms of study through recognised Australian Institutions. The study Noel did in philosophy linked with extensive debating competitions at local, state and interstate level enhanced the use of his analytical ability. Noel regrets that there is an apparent lack of philosophical studies and of logic among many students today. Mr Ian Macfarlane, in paying tribute to the work of Rev Noel Park said that Noel had the ability to grasp issues and to make an issue into an issue, presenting it in a way that people could understand. There is no doubt that this ability gave Noel the opportunity for great media exposure as he was able to speak on social issues with credibility.

Noel was, until his retirement, the Queensland's Synod spokesperson on rural issues, as well as being the State Disaster Co-Ordinator for the church. For Noel, issues of Social Justice were never divorced from his belief in God. Noel believed in God who is One of us and not a remote God needing vehicles of communication but who used Jesus as "mediator" and through whom God and people are joined. In this joining the voices of the marginalised, the unjustly treated, and the "lepers" of our society are heard and ministered to through the love God, who shares their pain, shares with them.

Retirement was not part of Noel's agenda when he was forced to leave Lifeline on the grounds of health. This impacted his ability to participate in ministry after retirement, he did volunteer as a JP for a number of years.



The church thanks God for the ministry of Rev Dr Noel Park performed in the name of Christ. Well done good and faithful servant.

Personal Reflection from Noel on his retirement

When I candidated for training as a Methodist minister I think my expectations of what this would mean were fairly simple, if not naive. However the 37 years since then have been anything but simple and I thank God for opportunities for involvements and experiences which I could never have anticipated. However, my primary reflections concern the people with whom we have worked. In each congregation and broader community there have been those who became our close friends and have been an important part of our lives.

Each congregation has also included some who were not seen as leaders and were rarely heard venturing an opinion but whose deep faith meant that when my faith was under pressure or some wise counsel was needed they were the ones to whom one could turn. I am deeply indebted to them.

Together with my wife Lyn and our three children I have had unique opportunities. The first Queensland Methodist to be Minister of a cooperating parish in Victoria where Methodist, Presbyterian and Anglican Churches and the Churches of Christ jointly inducted me as their minister in the (then) new community of Churchill; the opportunity to establish a new program of support for Aboriginal families in Victoria; to be the only formal representative of the churches invited to be a member of both the Queensland Rural Summits and the National Rural Financial Summit and Synod spokesperson on Rural Issues for around 15 years; extensive involvement in the work of Community Recovery from disasters; twenty years involvement in Lifeline; periods as acting Chairperson of Presbytery and chaplaincies in Mental Health, Industry, Tertiary Education.

I can only thank God for the people of Parishes, Presbyteries and Boards who walked with us, supported and encouraged us. Ministry has not been simple as we have travelled a complex road. There was so much still to be done when the formal journey was forced to end for health reasons but one of the joys of ministry is in knowing that others will bring their own skills to those tasks and that, if the tasks were indeed Christ's work he will work his purpose out.

There are things I would have done differently and relationships I would have handled differently but I look back with thanks for the opportunities and for the real presence of God throughout my ministry. My ongoing prayer for the Uniting Church is that we will be more reticent in making pronouncements, despite some sections of our church seeking these, and become more concerned with hearing the voices of the marginalised, the unjustly treated and the "lepers" of our society and assist them to know the God who shares their pain and would love to share their joy.

Rev Raymond (Ray) Townsend

The foundations for Raymond John Townsend's call to the ordain ministry within the Methodist and Uniting Churches have their roots in the post war community of Townsville in general and the Garbutt Methodist Church in particular.

Ray was born to Jack and Esther Townsend on 25th July 1941. Although he was baptized, he was raised in an essentially nonworshipping family. In those early years he had little or no contact with the church. He was basically an "outsider" or "fringe dweller". This changed when a Mr and Mrs Brown who had a passion for

ministry to young people, invited Ray to join the youth group at the church. Here he found a home and acceptance. The Browns had fulfilled the baptismal vows the church had made years before.

During his time in theological college, Ray encountered and embraced the Wesleyan and Reformed traditions as they related to baptism. With his understanding and own experience, Ray was very passionate about the baptism of all people, particularly infants and children. This has been a strong emphasis throughout his ministry.

In that same youth group Ray met Margaret Morris. Ray and Margaret were married in Townsville in December 1966. They would journey together faithfully for over fifty-eight years. It was Margaret who quietly encouraged and supported Ray during his three years in theological college and two years on probation.

While Ray was giving significant time to ministry in parishes and community settings, Margaret took the major role in raising their four children- Michelle, Peter, Adele and David. Ray was forever grateful that it was Margaret who managed the family finances.

Within the Garbutt Congregation Christ found Ray and here he confirmed the faith that had once been accepted for him in baptism. In this context the call to the ordained ministry began as Ray was given the opportunity to become a local preacher across several preaching places in the area. This call reached a significant milestone when he was ordained at the annual Methodist Conference in Brisbane in October in 1971. He retired in late 2005.

He served in the following parishes and congregations- Ashgrove (1969-1970), Yeppoon (1971-1974). Caloundra (1975-1979), Kingaroy (1980-1983), Rockhampton (1984-1989) and Blackall Range (1991-1998). In 1990, Ray was the Director of Lifeline Central Queensland and between 1999 and his retirement in 2005, he was chaplain to Sinnamon Village at Seventeen Miles Rocks.

That call to ministry at Garbutt was so strong that Ray, having not matriculated from high school determinedly set about conquering all obstacles so that ordination would become a reality. He did not find studying easy. He lived at Methodist Training College and Bible School for six years (1960-1965) where he studied part-time and worked part-time and achieved matriculation and accreditation as a lay preacher, both prerequisites for the ordinand course. After three years (1966-1968) in the Methodist Theological Hall at Kings College, Ray graduated and completed the necessary period on probation at Ashgrove, before his ordination took place in 1971.

Continuing education was important for Ray. A significant achievement was his being awarded a post-graduate Diploma in Religious Education by Griffith University in 1985.

His determination to succeed against the odds was reframed in the way he mentored and tutored several young people along their roads to future ministry.

All of the parish and congregational placements provided Ray with opportunities to make significant ministry connections with people outside congregational life. He loved ministering to and with "outsiders". The Blue



Nursing Service, (BlueCare), in Yeppoon, Caloundra, Kingaroy, and Maleny, Lifeline in Central Queensland, Hospital Chaplaincy in Kingaroy, Chaplaincy at Central Queensland University, involvement with the Christian Television Association and Christian Radio in Rockhampton, all provided Ray with extensive pastoral interactions with people outside the church. Rotary was also a significant ministry bridge to and through the communities in which he served. Ray was presented with a Paul Harris Fellowship Rotary Award when he lived in Maleny.

Ray worked comfortably in parishes by himself. He was also a valued and respected team member in multi placement environments. Team unity was something he strove for at all times.

Ray died on the 11th March 2025 and his funeral service was held at the Caloundra Uniting Church on the 19th March. Friends gathered with his family after the service to celebrate his life at Moffat Beach with fish and chips, Ray's favourite.

The Queensland Synod gives thanks to God for the ministry of Rev Raymond John Townsend and expresses its sympathy to Margaret, Michelle, Peter, Adele, David and their families.





Rev Michael Veary

Rev Michael Veary was born on the 3rd October 1938 in Salisbury (now Harare). A boy to Leslie and Iris Veary and a brother to older brother Robin. Michael lived his early life in what was then known as Southern Rhodesia (now Zimbabwe) attending Blakiston Junior and Churchill High School. The family attended Trinity Methodist Church, where Michael was a Sunday School teacher, youth leader and lay preacher. It was here, as a teenager, that Michael committed his life to Jesus. Michael's ministry years can be characterised over three distinct time frames and continents.

England (1957 – 1962)

Michael moved to England to train as a minister. He attended 2 years of biblical studies at Cliff College, Derbyshire before moving to Didsbury College, Bristol from 1959-1962 where he undertook Theological Studies for Ministry. As part of his ministry training, and with no family in the UK, Michael would often volunteer to preach at Sunday services in many of the local churches. Michael loved the outdoors and filling in for weekend preaching appointments allowed him to travel all around the UK. Michael met Doris, on one such local appointment, when he was the guest speaker at the Oldbury-on-Seven Sunday School anniversary. They were married three years later on the 16h June 1962 at Thornbury Methodist Church. Michael was ordained in 1962 and in December of that year they sailed to Cape Town.

Rhodesia (1963 – 1980)

Michael was placed by the Methodist Presbytery to two Mission Stations outside of Salisbury. Being a minister here meant many things, an inspector & supervisor of school buildings, constructor of water tanks and electrician with the wiring houses with electricity connected to a diesel generator! Much of Michael's ministry at this time was during civil unrest and war. The two children, Karen (1964) and Andrew (1969) were born during this period. Michael taught Religious Education in several schools, started a Vestry Hour, ran services in the local mental hospital and became Chairman of the Area Council. In 1971 Michael accepted a call to the multi-congregation Gwelo Presbyterian church. During their ten years here, Michael was Moderator for two neighbouring parishes, set up youth groups, home fellowship groups as well as being an active member of Rotary. For eight years, during the time of civil unrest, Michael was made Chaplain to the Army, Air Force and Police, rising to the rank of Major before emigrating to Australia. When Rhodesia became Zimbabwe in 1980 there was a rapid decline in safety, health facilities and education. After much prayer, Michael & Doris accepted the call to the Uniting Church in Shepparton, central Victoria.

Australia (1981 – 2024)

The Veary's arrived in Victoria January 1981, to Scots Uniting Church Parish in Shepparton which included farming congregations of Pine Lodge and Dookie and in 1985 the family moved to Leopold Uniting Church near Geelong. In both parishes, Michael instigated his tried and trusted management plan for congregation growth introducing Vestry hours (for visitations outside of normal office hours), youth groups, men's nights, home fellowship bible studies, and teaching Religious Education in local schools. In Leopold he also became the Chaplain to the Scouts Troop and President of the Lions Club.

After a decade in Victoria, Michael accepted a call to the Stafford Parish in Brisbane. Again, Michael implemented his vision plan for growth, encouraging Sunday school attendance, establishing women's associations and youth fellowships. He was involved in Crossroads (for people with disabilities), was the secretary for Continuing Education for Ministers and ran a couple of terms as President of the Aspley Lions Club. In 1989 Michael and Doris moved to a placement in the Balmoral Parish which included the congregations of Morningside and Bulimba. Here Michael was instrumental in employing a second minister to run a more vibrant contemporary morning family service while he ran the earlier more traditional service.



Michael's ministry was not only recognised within his congregations, but also in an advisory capacity to the Queensland Parliament and local civic councils, especially in the leading of the local Dawn Services for ANZAC Day.

Michael retired from ministry in January 2004 but continued to guide and counsel people within his local community. He had lived through the loss of his brother at a young age, witnessed the atrocities of war in his homeland, and took a leap of faith to move across the globe, though through it all, his faith in the Lord did not falter.

Michael passed away in July 2024.
