Finance Investment and Property Board MEETING DATES FOR 2024

About

The Finance, Investment and Property Board ("the FIPB") assists and advises the Synod Standing Committee (SSC) in fulfilling its financial responsibilities to exercise due care, diligence and skill in:

- (a) performing functions of the Synod Property Board under Regulation 4.2.1
- (b) exercising oversight of activities conducted under Regulation 3.7.4.6
- (c) perform such other functions delegated by Synod.

The FIPB assists the SSC in the oversight of Synod's¹ activities in accordance with the responsibilities of it's Charter. Property includes both real and personal property.

The functions of the Synod Property Board are carried out by the Finance Investment and Property (FIP) Board which meets monthly (usually on the 4th Friday of the month).

The Board, amongst other duties, will:

"...(d) receive proposals with respect to property matters submitted to it by the Presbyteries, Church Councils, institutions or agencies, ensure that each proposal is in accordance with the policies of the Synod with respect to property matters, development and mission and give the final decision with respect to such proposals; ..." (Uniting Church in Australia, Regulations, 4.2.1)
