#### **Purpose**

This document assists the church council to determine the suitability of the applicant to transport participants on behalf of the Church.

#### **Instructions**

- 1. This document is to be utilised by the person seeking approval to use their vehicle and/or transport participants, to and from specific church activities and programs.
- 2. This document requires approval from the Church Council.

- 3. Before any person can provide transport for children, an additional screening process must be undertaken and documented (see the additional screening section on this form).
- 4. The applicant is required to hold an 'Open' car license, or to have at least 24 months of licensed driving experience for the other license types detailed below.
- 5. If an applicant holds a Driver's License from a state other than Queensland including an International Driver's License, then additional information will be required to determine suitability and safety. Please attach details on an additional sheet, which demonstrates that the applicant holds a license equivalent to an 'Open' Queensland Driver's License, and that the applicant is familiar enough with Queensland Road Laws and Road Safety, to represent the church when transporting passengers.
