#### When to follow this process

This process must be followed each time a ministry agent reasonably suspects that anyone has been abused or is being groomed for abuse. This includes all concerns relating to:

- Breaches of the Code of Conduct (Statement of Personal Commitment)
- Current neglect and/or abuse of children or adults
- Previous abuse of children who are now adults
- Abuse committed by children
- · Spiritual abuse, domestic and family violence, boundary violations, bullying or criminal misconduct

#### R.E.S.P.O.N.D. process and checklist

Note: the order of the steps may vary depending on the particular circumstances and situation.

- Reassure Reassure the person: "I'm glad you told me"; "It's important for this to be addressed" or similar words that welcome the information. Listen calmly, patiently, and supportively. Let the person or child use their own words. If someone has decided to talk to you, it is a sign that they trust you. You are helping them by listening respectfully to what they have to say. Let them know they are doing the right thing by speaking up, that you believe them, and you are taking what they say seriously.
- Ensure Ensure immediate danger has been addressed. Address any concerns about their safety, especially if they are worried about the consequences of disclosing. Tell them that what happened to them is not their fault. If there is imminent danger call 000. You may need to ask a few questions to get enough information to be able to determine immediate safety concerns. However, do not investigate. An interpreter service or a communication aid may be required to assist the child or person to adequately disclose their concerns and allow clear communication to occur. Manage the child or person's expectations by explaining to them what the next steps will be. Be clear that you may need to tell other people certain things about their experience. Explain you have a responsibility to report abuse concerns and allegations.
- Statement The template for complaints and allegations must be completed with detailed notes. Do not investigate. You may need to ask a few questions to get enough information to be able to determine immediate safety concerns. Record those to whom you have reported your concerns, both within and outside the church. Take notes as you go, keep a copy for yourself and provide a copy to the Church. Ensure notes are secured and kept confidential. Keep a copy of your notes and who you've spoken with in a secure location and provide a copy of the report to the Safe Church Assurance and Support Officer at the Synod office safechurch@ucagld.com.au or call 07 3377 9833.
- **Plan** Plan your next actions. Complete the reporting threshold test (included in the document) to help plan the appropriate action.
- **Obligations** Obligations to report to both statutory and Church authorities must be met. Reporting is mandatory under both state legislation and Church policy.
- Needs Needs for practical assistance and referral should be attended to. The reporting and referral guide will assist you to find the contact details. Ask the child or person what they need from you or the Church so they can feel safe and involved in the process. Offering a follow up phone call or personal visit or providing a phone number (your number or the person who will be supporting them) for them to call is an appropriate option to continue pastoral care. Consider whether pastoral care is required for the accused if they are also involved with the Church.
- **Debrief** Debrief with other leaders and volunteers that have been involved in the process. Make sure to prioritise self-care and debrief with your supervisor or a trusted colleague, maintaining confidentiality. Your Presbytery Minister is also an option for debriefing and support.

**NOTE:** in the event of a reportable incident involving a child, follow the reporting process, and notify the parent or guardian, unless they are the alleged offender.

Pastoral Care (Responding to victims of Domestic and Family Violence)

- Listen Being listened to can be an empowering experience for a person affected by violence. Give them space to tell their story and be empathetic and compassionate, without judging. Stay in touch and maintain your support, especially following a separation. If the victim chooses not to leave the abusive relationship it is very important to stay connected and continue offering support. Give them the chance to speak in private. Be prepared to listen, but don't force them to speak if they are not ready. An interpreter service or a communication aid may be required to allow clear communication to occur.
- Validate and believe them Often people are not confident to tell their story in case they are not believed. You can help a person feel stronger by showing you believe what they say, no matter what they share. Build their confidence, respect their decisions, and tell them about the services available for support.
- Be clear that they are not to blame People who are experiencing domestic and family violence can often feel incredibly scared and unsure of themselves. You can say things like: 'Violence is unacceptable. You do not deserve to be treated this way.' <u>Avoid asking</u>: 'Why don't you leave?', 'What could you have done to avoid this situation?' and 'Why did they hit you?', as these might suggest they could control the violence by managing their behaviour. Don't make excuses for the person who has hurt them.
- Protect their safety and your own. For example, do not tell the abusive person where their
  partner is or how to get in touch with them. Understand that they may not be ready, or it may
  not be safe to leave. Don't try to force them to do what you think is best. Seek advice from
  support services so you can find out more about local assistance.
